Annual License Renewals Required

All licenses issued by the Board expire on December 31st of each and every year.

October 1st of each year marks the beginning of the annual renewal period for all licensees. All licenses issued by the Board expire on December 31st of every year and must be renewed annually in order to engage in activities requiring licensure.

Renewal notices will be mailed to all licensees during the first week of October, at the address on file with the Board. The notices will contain the user name and password which allows you to use the online renewal service and a credit card. The online renewal option is available to licensees whose license will expire in 2016, and have no changes to make to the trade name or sub-licensees. Licensees are responsible for renewal, even if no notice is received due to incorrect addresses or delivery issues with the U.S. Postal Service.

If your license expired in 2013, 2014, or 2015, or if you need to make changes to the trade name or sub-licensee listing, licensees must complete the form that is received and submit it to our office with check or money order as in years past. You may also submit the paper form and payment if you do not have access to the internet or do not wish to renew online.

THERE IS NO GRACE PERIOD AFTER DECEMBER 31st!

If the license is not renewed by December 31st all bidding, contracting, and any in-progress work on jobs requiring a license must cease until the license has been restored to active status. Local inspection departments have the right to deny permit applications if a license is expired.

Every year our office staff and field representatives receive calls throughout the months of January, February and March from contractors in a panic because they cannot obtain permits for a job that they need to start immediately. By renewing before December 31st, licensees can avoid these issues and any job delays that may result from the expiration of the license.

We cannot renew licenses over the telephone, and we cannot renew licenses while you wait if you visit our office. If submitting your renewal form and payment to our office, please understand that it may take 2-3 days to process the renewal and reactivate the license. The local inspection department is under no obligation to issue a permit until the renewal has been processed by our staff and the license is showing as active for 2017 on the Board's website.

Licenses renewed after January 31st will also be subject to a \$25.00 late renewal processing fee. This is simply an opportunity to renew during January without paying a late fee, and is not a grace period during which licensed activities can be continued without renewal.

Is Your Information Correct?

The Board's laws and rules require that licensees provide the Board with current information regarding the name in which business is being conducted and the current addresses. These requirements are important to the licensee for a number of reasons.

If the licensee is doing business in any name that is different from that which is on file with the Board, there is not only a risk of being disciplined by the Board, but there is also a risk that any mechanic's lien or small claims settlements may be denied due to the fact that contractual agreements were made in a name that is not associated with the license.

If the licensee has not provided the Board with a current and valid address, the licensee may not receive mailings from the Board, such as license renewal notices and other special announcements.

If a licensee wishes to check the name and address currently associated with the license, the License Search feature of the Board's website may be used. By simply entering the license number, the information will be displayed for review. The License Search function may be accessed by clicking this link: <https://onlineweb.nclicensing.org/Lookup/LicenseLookup.aspx>

If a change needs to be made to the trade name, the Trade Name Change form should be completed and submitted to the Board's office with the processing fee. If only the address needs to be changed, the Address Change form should be completed and submitted, and there is no fee for this form.

Proposed Rule Changes - Notice of Public Hearing

On July 22, 2016, the House Bill 742 was signed into law, which amended North Carolina General Statute 87-21. This change requires the State Board of Examiners of Plumbing, Heating and Fire Sprinkler Contractors to begin issuing a number of new licenses created by the amendment. The new licenses will be known as the State and Local Government Technician license, and will be issued for plumbing as well as for heating groups 1, 2 and 3. The effective date is October 1, 2016; however, before licenses can be issued the Board must establish new rules to address the new licenses.

The Board has submitted the proposed rules to the State as required by law, and will be conducting a public hearing on the proposed rules in order to receive public comment. House Bill 742 resulted in the following amendments to GS 87-21:

GS 87-21. Definitions; contractors licensed by Board; examination; posting license, etc.

(b)(2)(c) The Board shall establish and issue

1. A State and local government plumbing, heating group number one, heating group number two, or heating group number three technician license for use by persons who do not possess the required plumbing, heating group number one, heating group number two, or heating group number three contractor license but desire to engage in the installation, repair, or replacement of plumbing, heating group number one, heating group number two, or heating group number three solely as an employee of a State or local government agency.
2. A State and local government plumbing, heating group number one, heating group number two, or heating group number three technician license for use by persons who do possess the required plumbing, heating group number one, heating group number two, or heating group number three contractor license but also desire to engage in the installation, repair, or replacement of plumbing, heating group number one, heating group number two, or heating group number three as an employee of a State or local government agency without listing their contractor license in the name of the State or local government agency. Licensed contractors who obtain the State and local government technician license shall be allowed to contract and perform work under their contractor license only during hours such contractor is not actively employed with the State or local government as a technician, and is on-site carrying out the contracting activity personally. No work can be performed by the State or local government agency in reliance upon the technician license when the licensee is not present.

The following rules are proposed by the Board in response to the amendments in GS 87-21.

21 NCAC 50 .0312 STATE AND LOCAL GOVERNMENT PLUMBING OR HEATING TECHNICIAN

is proposed to be adopted as follows:

(a) In order to determine the qualifications of an applicant for a license as a State or local government plumbing or heating technician, the Board shall provide a written or computer-based examination in the following categories:

- (1) State and Local Government Plumbing Technician
- (2) State & Local Government Heating Group No. 1 Technician
- (3) State & Local Government Heating Group No. 2 Technician
- (4) State & Local Government Heating Group No. 3 Technician

(b) Applicants for a license as a State & Local Government Plumbing or Heating Technician must obtain a license based on experience set forth in Rule .0312(c) and must pass the Class I technical and Board laws and rules part of the Board-administered examination related to the category for which a technician license is sought. Such applicant need not pass the business part of the examination.

(c) Applicants for a license as a State & Local Government plumbing or heating technician shall present evidence adequate to establish 3000 hours of full-time experience in the installation, maintenance, service or repair of plumbing or heating systems related to the category for which a technician license is sought, whether or not a license was required for the work performed.

(d) Applicants for a license as a State & Local Government Technician who currently hold an active plumbing, or heating contractor license issued by this board may qualify for the corresponding State and local government technician license without examination. 21

21 NCAC 50 .0313 RESPONSIBILITIES OF STATE AND LOCAL GOVERNMENT TECHNICIAN LICENSEES

is proposed to be adopted as follows:

(a) A licensed state & local government technician licensee shall be required to list their license with the Board in the name of the state & local government agency by whom the licensee is employed,

(b) The holder of license as a State & Local Government Heating, Group 1 Technician, Heating, Group 2 Technician, Heating Group 3 Technician or Plumbing Technician shall be a full-time employee of a State or Local Government agency.

(c) A licensed state & local government technician licensee shall ensure that a permit is obtained from the appropriate state or local Code Enforcement official before commencing any work for which a license is required by the Board. The licensee shall also ensure that a request for final inspection of the work for which a license is required is made within 10 days of the earlier of the system being made operational or placed in service, absent agreement with the appropriate state or local Code Enforcement official. Absent agreement with the local Code Enforcement official the licensee is not relieved of responsibility to the Board to arrange inspection until a certificate of compliance or the equivalent is obtained from the appropriate state or local code enforcement official or the license has clear and convincing evidence of his effort to obtain the same.

(d) The failure of a licensee to comply with the permit and inspection obligations outlined in this Rule shall be considered by the Board as evidence of incompetence or misconduct in the use of license from the Board. (e) A licensed state & local government technician licensee is responsible for general supervision to the extent of his qualifications, compliance with all applicable codes and standards, and assurance that permits and inspections are obtained.

(f) The general supervision required by G.S. 87-26 is that degree of supervision which is necessary and sufficient to ensure that the work is performed in a workmanlike manner and with the requisite skill and that the installation is made properly, safely and in accordance with applicable codes and rules. General supervision requires that review of the work done pursuant to the state and local government technician license be performed by the state and local government technician licensee while the work is in progress.

(g) In each state or local government agency location, branch or facility of any kind from which work requiring a license pursuant to G.S. 87, Article 2 is carried out there shall be on duty the lesser of 1500 hours annually, or all hours during which the activities described herein are carried out, at least one individual who holds the appropriate state & local government technician license in the classification required for the work being proposed or performed, whose license is listed in the name of the particular state or local government agency at that location, and who is engaged in the work of the state or local government at the agency location or at an agency job site and who has the responsibility to exercise general supervision over the work and who has been empowered to act for the state or local government agency, as defined in Rule 21 NCAC .0505 of this Chapter, of all work falling within his license qualification. Evidence of compliance shall be required as a condition of renewal or retention of license and falsification shall constitute fraud in obtaining license. The standards set forth in Rule 21 NCAC 50 .0512 shall be applied.

(h) An unlicensed person who is directly and regularly employed by state & local government agency licensed pursuant to G.S. 87, Article 2 is not required to have a license and shall not be subject to an action for injunctive relief brought by the Board if the unlicensed person is a bona-fide employee of the state & local government.

(i) The annual license fee for a State & Local Government Technician license is one hundred thirty dollars (\$130.00), except as provided in subsection (j) below.

(j) The annual license fee for a State & Local Government Technician Plumbing or Heating Technician license which is listed as the second or subsequent licensee at the same agency location is sixty-five dollars (\$65.00).

21 NCAC 50 .0405 MULTIPLE LICENSES

is proposed amended as follows:

(a) In order to maintain the identity of firms and allow effective supervision, each licensed contractor or technician shall qualify only the business location where he is primarily located.

(b) A licensee may be listed on only one contractor license at any given time, whether the license is issued in the name of the individual or in the name of a firm; provided, however, that the fire sprinkler maintenance technician qualification and the state and local government technician qualification may be listed separately in the name of the employer to which restricted.

(c) The holder of qualification as a contractor may, upon deletion of his name and qualifications from a firm license, reinstate his personal license, either as an individual or in the name of some other corporation, partnership, or business that has a trade name, upon compliance with G.S. 87-26.

(d) A technician licensee, other than the holder of a Fire Sprinkler Maintenance Technician license, may, upon deletion of his name and qualification from a firm license, move his qualification to another licensed corporation, partnership or business which has a trade name, upon compliance with G.S. 87-26. 14

21 NCAC 50.0414 SUPERVISION IN ABSENCE OF INSPECTION

is proposed to be adopted as follows:

In lieu of the supervision required by 21 NCAC 50.0505, the holder of the qualifications upon which a license is based shall personally examine all work performed in reliance upon the license at completion and before the work is placed in service to assure that the installation, replacement or repair is performed in compliance with the current edition of the NC Building Codes and the manufacturers installation instructions, where the work will not be examined and approved by a person holding qualification from the Code Officials Qualification Board.



Resolution Agreements

A Field Resolution Agreement is a voluntary agreement by which a licensee enters into some type of sanctions against their license instead of appearing before the Resolution Review Committee or the Full Board at a formal hearing. All of the Agreements are reviewed by a member of the Resolution Review Committee and then presented to a Board hearing panel for approval prior to the agreement being adopted as a final agency decision. If a complaint has not been resolved in the field through a Field Resolution Agreement, then the case can be referred to the Resolution Review Committee. During the Resolution Review Committee meeting, a licensee can enter into a Review Committee Resolution Agreement in place of appearing before the Board at a formal hearing; the agreement is then presented to a Board hearing panel for approval prior to the agreement being adopted as a final agency decision. Cases that cannot be resolved through the use of Field Resolution Agreements or Review Committee Resolution Agreements are forwarded to formal hearings before the Board. Listed below are the different agreements entered into by the field staff and the Resolution Review Committee that have been approved by the Board. The information below does not contain all of the facts or details of each case. Allegations of misconduct and job abandonment in the business of plumbing contracting in that the licensee failed to provide supervision, and the firm, Mean Green Energy Enterprises, obtained money from a homeowner for work not performed,

Resolution Conference held 06/30/2016.

The license of Daniel Baker, number 12199 P-I, and the license of the firm, Mean Green Energy Enterprises, be suspended for a period of twelve (12) months. Among other requirements during the suspension, the licensee shall enroll in, attend and complete the Special Board Laws & Rules course. Upon successful completion of the suspension, his license and that of the firm shall be placed on supervised probation for a period of thirty-six (36) months. Among other requirements during the probation, the licensee must only contract and perform work that is located in areas that are easily and fully accessible by a wheel chair. No work can be contracted or performed under his license where the work is located in a crawlspace, in an attic or in an area where the licensee cannot physically review from his wheelchair. If the firm employees another properly licensed plumbing contractor then the firm can contract the above restricted work but the other licensee shall be responsible for all supervision on work in those limited accessible areas. Within sixty (60) days of the start of the probation the license shall present evidence to the Board that he has purchased the current editions of the following books: Title 21, Chapter 50 of the North Carolina Administrative Code (Board Laws & Rules), the North Carolina Plumbing Code, the North Carolina Administrative Code and Policies, the North Carolina Energy Code and the North Carolina Fuel Gas Code. In the event of violation of any of the conditions of probation, license of the individual and of the firm will be suspended for a period of eighteen (18) months, with the requirement that prior to the suspended license being reinstated the licensee

and the firm agrees to comply with all of the probation provisions listed above.
