New Year Brings New Rules

Rules changes that were approved in 2012 are now in full effect for 2013. The major changes are briefly described in the articles below.

Continuing Education Program Eliminated

Following a lengthy process, the requirements for mandatory continuing education as a condition of annual license renewal have been repealed. The Board encourages all licensees to attend continuing education classes of their choice in order to remain current on codes, technologies, and changes in their respective trades. The Board no longer approves providers, instructors, or classes, nor will the Board maintain records on continuing education classes attended by licensees.

In the near future a page will be added to our website to assist licensees in locating available classes. The name and contact information for the provider will be published, along with a listing of the type of classes that are offered. Specific information on class dates, times, and locations will not be provided by the Board...the licensee should contact the class provider for information concerning the classes.

New Technician License for Plumbing, Heating, and Fuel Piping

The technician license allows an individual to supervise work for a firm for which he/she is employed and listed as a sub-licensee under a licensed contractor. The license may be obtained by applying and passing the technical examination. At any time after that, the technician license may be upgraded to a contractor license by applying and passing the business and law examination.

The technician license is not a contractor license, and is limited to supervision of work within the technician's qualification(s). It is primarily intended to provide some relief to contractors who have multiple jobs or jobsites over a large area, by allowing the technician(s) employed by their firm to perform the supervision duties that are required of the contractor.

The exception is that a Fuel Piping Technician may contract work if he/she is employed by a gas dealer or provider who meets the requirements as set forth in 21NCAC50.0404(d).

Background Check and Examination Required for Fire Sprinkler Maintenance Technicians

The Fire Sprinkler Maintenance Technician license allows full-time maintenance employees of a firm to perform limited maintenance duties on fire sprinkler systems at the location of the employer.

This license was previously issued on experience alone; however, during the recent rules review that was conducted and approved by the North Carolina Rules Review Commission the Board was ordered to require examination for this license, as is required for all other licenses that the Board issues. The criminal background check requirement also now applies to all applicants for this license, as it does to all other applicants for licenses currently issued by the Board.

Holiday & Inclement Weather Closings

Most Frequently Asked Questions Regarding License Renewal

Why is the local inspection department refusing to issue a permit to me?

It may be due to the fact that your license is not showing as active when the permitting personnel check the Board's website.

Why doesn't my license information show up on the license search on the Board's website?

Only currently active licenses will be returned by the license search feature. Licenses that expired on December 31, 2012 or earlier will not be shown.

Isn't there a grace period on license renewal?

No. All licenses expire on December 31st of each year, regardless of issue date. The license may not be used for any activities requiring licensure (bidding, contracting, permitting, installations, etc.) until it is renewed by the office staff. There is a grace period on the late processing fee, which applies to all licenses not renewed by January 31st of the year following expiration.

How quickly can my renewal be processed?

Processing times vary based on the volume of renewals received and may take up to 2-3 business days. The license is not considered active until it has been processed. Immediately following processing, it will be shown as valid for 2013 on the license search feature of the website.

Can I renew a license by phone, fax, e-mail, or online?

No. A completed renewal form and payment in the form of a check or money order is required to renew a license. Since payment cannot be made via phone, fax, or e-mail, licensees must currently mail in the form and payment, or bring it to the Board's office in person. We had hoped to have online renewal available, but issues with our software provider have delayed this project. There is a notice at the top of the homepage on our website regarding this, and as soon as online renewal becomes available it will be noted there.

Do I have to have continuing education classes to renew my license?

No. All rules concerning continuing education were repealed effective December 31, 2012. The Board still encourages licensees to attend CE classes to remain current in their trades, but the Board will no longer approve the classes or publish information regarding class dates, times, and locations. We are working on a new page for our website which will allow licensees to see a listing of all providers, the type of classes that they offer, and their contact information.

Why didn't I receive a renewal form, and how can I get one?

The most common reason for not receiving a form is a change of address that the Board was not notified of. All Board forms are available for download and printing from our website by clicking on the Download Forms page. In addition, the staff will be happy to mail, fax, or e-mail any of our forms to anyone who has difficulty downloading from our website.

Field Resolution Agreements and Resolution Review Committee Agreements

A Field Resolution Agreement is a voluntary agreement by which a licensee enters into some type of sanctions against their license instead of appearing before the Resolution Review Committee or the Full Board at a formal hearing. All of the Agreements are reviewed by a member of the Resolution Review Committee and then presented to a Board hearing panel for approval prior to the agreement being adopted as a final agency decision. If a complaint has not been resolved in the field through a Field Resolution Agreement, then the case can be referred to the Resolution Review Committee. During the Resolution Review Committee meeting, a licensee can enter into a Review Committee Resolution Agreement in place of appearing before the Board at a formal hearing; the agreement is then presented to a Board hearing panel for approval prior to the agreement being adopted as a final agency decision. Cases that cannot be resolved through the use of Field Resolution Agreements or Review Committee Resolution Agreements are forwarded to formal hearings before the Board. Listed below are the different agreements entered into by the field staff and the Resolution Review Committee that have been approved by the Board. The information below does not contain all of the facts or details of each case. Allegations of misconduct in the business of fire sprinkler contracting in that the licensee failed to properly document a backflow test on a device which yielded a passing report when the backflow should have had a failing report. Resolution Conference held 09/17/2012
James Baynard signed a Resolution Conference Agreement 09/17/2012.

The license of James Baynard, number 29172 FSIT, and that of the firm shall be placed on unsupervised probation for a period of twelve (12) months. Among other things during the probation, the licensee must ensure that a licensee of the firm who holds the proper licensing qualification shall personally and thoroughly review all phases of work to assure that the all testing and inspections meet or exceed the minimum standard of NFPA 25, assure that he always properly documents all inspection data to the proper form for each specific job,

licensee shall enroll in, attend and complete the Special Board Laws & Rules course approved by the Board's Executive Director within 90 days of signing the conference agreement, and in the event if the licensee violates the conditions of probation, his license will be suspended for a period of three (3) months, with the requirement that prior to the suspended license being reinstated he must comply with all of the probation provisions.

Resolution Conference held 09/18/2012.

James Dorton signed a Resolution Conference Agreement 09/18/2012.

That license of James Dorton, number 22092 H-1,2 & 3-I, and that of the firm shall be placed on unsupervised probation for a period of twelve (12) months. Among other things during the probation, the licensee shall submit a letter to each homeowner, certified mail return receipt, notifying the homeowner that the installation performed is required by state law to be inspected by the local inspection department and that failure to have the installation inspected could lead to the electrical or gas service being disconnected from the structure by the local code enforcement official. The letter should ask that the homeowner to notify the licensee within 10 days of receipt of the letter to schedule a date for inspection. Within 15 days of sending the original letter, the licensee shall send a second letter, certified mail return receipt, to those homeowners who have failed to respond in the timeframe prescribed above, notifying the homeowner that the installation performed is required by law to be inspected by the local inspection department and that failure to have the installation inspected could lead to the electrical or gas service being disconnected from the structure. A copy of both letters shall also be sent to the appropriate local code enforcement official's office and to the Board's office. The licensee shall enroll in, attend and complete the series of three - six (6) hour sessions of the Special Mechanical Code course. In the event the licensee violates the conditions of probation, his license will be suspended for a period of three (3) months, with the requirement that prior to the suspended license being reinstated he must comply with all of the probation provisions.

William Fortiscue signed a Resolution Conference Agreement 11/07/2012.

The license of William Robert Fortiscue, number 30752 H-3-II, and that of the firm shall be placed on supervised probation for a period of twelve (12) months. Among other things during the probation, within 90 days of signing the agreement, the licensee must enroll in, attend and complete the two day, 16 hour Special Contractor Business Management course. If the licensee violates the conditions of probation, his license will be suspended for a period of six (6) months, with the requirement that prior to the suspended license being reinstated he must comply with all of the probation provisions.

Allegations of misconduct and incompetence in the business of heating contracting in that the licensee was hired by a general contractor to perform the complete installation of two HVAC systems, during the initial installation the licensee failed to install dampers in the supply runs but later returned to install several dampers, which still did not alleviate the problems with uneven temperatures.

Brian Gentry signed a Proposed Resolution Agreement 10/24/2012.

The license of Brian Lee Gentry, number 20099 H-3-I, and that of the firm shall be placed on unsupervised probation for a period of twelve (12) months. Among other things during the probation, the licensee agreed to allow the homeowner, who resides at 708 Windalier, to hire an HVAC contractor of their choice to perform any and all corrections to the second floor HVAC system he installed, with the understanding that the corrections might include sizing and duct issues. The licensee voluntarily agreed to reimburse the homeowner 100% of the cost for these sizing and duct repairs within 30 days of receiving an invoice for the repairs. If there is a sizing issue, a load calculation will be provided to the State Board for review to confirm the findings.

In addition, the licensee must enroll in, attend and complete the two (2) day, 16 hour Special Mechanical Design course within 90 days of signing the agreement, and licensee must enroll in, attend and complete the series of three - six (6) hour sessions of the Special Mechanical Code course. In the event the licensee violates the conditions of probation, his license will be suspended for a period of three (3) months, with the requirement that prior to the suspended license being reinstated he must comply with all of the probation provisions.

Resolution Conference held 03/19/2012.

Review Committee recommended that licensee Ronald Shane Greene, number 24584 P-I, be provided ninety (90) days from the date of the conference to obtain the proper continuing education and renew his license to active status. If the licensee does not meet the timeframe as prescribed above, then the licensee shall return before the Resolution Review Committee where the license of Ronald Shane Greene shall be suspended for a period of one (1) year. The licensee was cautioned that if he failed to renew his license as prescribed above, then the one (1) year suspension would not take effect until such time as the license was renewed.

Resolution Conference held 09/20/2012.

Ronald Shane Green, although duly served with the Invitation Letter, failed to appear at the Resolution Conference.

Results from the 09/20/2012 conference were hand delivered and left at Green's residence on 10/22/2012.

Since Mr. Green did not meet the required timeline to renew his license within ninety (90) days of the date of the 03/19/2012 conference, the Review Committee recommended that the license of Ronald Shane Green, number 24584, and the license of the firm be suspended for a period of one (1) year, beginning when this agreement is approved by the Board. The one (1) year suspension will not take effect until such time as the license has been renewed. The license will be restored at the end of the suspension, provided that during the suspension the licensee shall perform no work that requires a license, except as a bona-fide employee of another properly licensed contractor, payment of all current and past renewal fees, and commit no further violation of Article 2, Chapter 87 or Rules of the Board with regard to any qualification administered by the Board.

Respondent denies the allegations above and contends that conditions on the site made it impossible to follow the plan. The Respondent further contends that no "P" traps had been installed in the rough plumbing due to the fact that the owner had given the Respondent technical information that showed that the appliance, a pedicure chair, would have a "P" trap within the appliance itself. Further, that due to the change in the hidden conditions, the Respondent requested a change order which was refused by the owner and the parties agreed that the Respondent would leave the job and refund the amount of \$587.50 of the \$5,000.00 initial payment due for the work done by the Respondent on the job. The Respondent contends that at the time the parties parted ways, the work done to that point had not been completed to the point when the Respondent would have called for an inspection and the Respondent had not called for an inspection and, Respondent further contends that she had received a permit prior to beginning work on the project.
