# **Limited Restricted Plumbing Contractor License Information**

Rules for the new license enacted by the North Carolina General Assembly during the 2012-2013 Session have been published and the licensing applications are now available. The dates and locations for the related plumbing and backflow certification classes have also been scheduled. Individuals interested in obtaining the new license are encouraged to read the full article and course offerings on pages 2 and 3 of this newsletter.

### Residential Fire Sprinkler Installation Contractor License Class Offered

The 16 hour course required for individuals who wish to obtain the Residential Fire Sprinkler Installation Contractor license has been scheduled for October 28 & 29, 2014, in Greensboro, NC. For more information regarding this license, please refer to the article on page 4 of this newsletter.

# Reminder for Plumbing Contractors Engaging in Well Pump Installation/Repair/Replacement

Plumbing Contractors who are not certified by the North Carolina Well Contractors Certification Commission, but who engage in the business of installing, repairing and or replacing well pumps or piping are reminded of the educational requirement to obtain the certification exemption.

In order to perform work inside a well without violating Well Commission rules and facing disciplinary action, a plumbing contractor must hold an active plumbing license from this Board and must have completed a course on well protection, sanitation and sealing no more than two years prior to performing the work.

In other words, plumbing contractors who wish to engage in well work should complete the required class every two years in order to remain in compliance. For more information regarding this exemption please refer to page 4 of this newsletter.

### **Limited Restricted Plumbing Contractor License**

In accordance with laws enacted by the North Carolina General Assembly during the 2012-2013 Legislative Session, the Board has published rules detailing the requirements for qualification and examination for individuals who wish to obtain a Limited Restricted Plumbing Contractor License.

This license if for persons who do not possess a Plumbing Contractor License, but wish to engage in the contracting or installation, repair or replacement of exterior building sewer piping, exterior water service piping of 2" diameter or less, exterior backflow preventers connected to water service piping of 2" diameter or less, and/or water filtration systems or components.

Applicants for this license must comply with one of the following paths to licensure:

- 1. Establish 1500 hours of full-time experience in the installation, maintenance service or repair of plumbing systems. Up to one-half of the experience may be in academic or technical training related to the field of plumbing.
- 2. Submit a completed application and fees to the Board.
- 3. Pass both the business & law part and the technical part of the examination.

#### OR

- Hold a currently active license from the North Carolina Irrigation Contractor Licensing Board: <u>and</u> hold a Backflow Inspector certification from a North Carolina municipality <u>or</u> demonstrate 500 hours of experience in the maintenance service or repair of plumbing system components.
- 2. Submit a completed application and fees to the Board.
- 3. Pass both the business & law part and the technical part of the examination.

#### OR

- I. Hold a currently active license from the North Carolina Irrigation Contractor Licensing Board: and hold a Backflow Inspector certification from a North Carolina municipality or demonstrate 500 hours of experience in the maintenance service or repair of plumbing system components.
- 2. Submit a completed application and fees to the Board no later than August 31, 2014.
- 3. Complete the plumbing code course offered by the Board
- 4. Pass the laws and rules part of the examination.

### **Limited Restricted Plumbing Contractor License Courses Offered**

This is the plumbing course being offered by the Board for currently licensed irrigation contractors who are interested in applying for the Limited Restricted Plumbing Contractor license before August 31, 2014. Applicants who are approved will be notified of the class date and location that they should attend (based on geographical proximity to the class sites). The two classes offered are as follows:

September 23, 2014 Raleigh, NC

September 25, 2014 Statesville, NC

#### **Backflow Certification Classes Offered**

Backflow Certification Course for currently licensed irrigation contractors who do not meet the 500 hour experience requirement and do not currently hold a backflow certification from an NC municipality. The class is a total of 40 hours, and interested individuals must contact the course provider directly for information and registration. The NC Irrigation Contractors' Licensing Board has also approved these classes for 10 credit hours.

### Residential Fire Sprinkler Installation Contractor License Class Offered

The Residential Fire Sprinkler Installation Contractor license is available to licensees who currently hold a plumbing license from the Board and have done so for the past two years. Interested individuals must submit a completed application, complete the 16 hour Residential Fire Sprinkler Contractor course and pass the examination.

The dates for this year's class is October 28 & 29, 2014, and it will be held in Greensboro, NC. Attendees may take the exam on-site immediately following the class, or at a later date.

Plumbing Contractors interested in obtaining the license should submit a completed application and fees (which includes class registration and minimal fee) no later than September 31, 2014.

### Well Pump Installation, Repair and Replacement Exemption

In 2009, plumbing contractors licensed by this Board were given an opportunity to receive an exemption to the requirement for a Level D Well Certification from the North Carolina Well Contractor Certification Commission.

In order to receive the exemption, the licensed plumbing contractor must attend a course no more than two years prior to the date that the work is performed. Therefore, in order to remain eligible for the exemption, a contractor would need to complete the course every two years.

During the years when the Board required mandatory continuing education as a condition of license renewal, class dates were published on the Board's website. With the elimination of the continuing education program at the end of 2012, the Board stopped listing individual class information on the site.

The website now contains a menu item titled "Education & Providers". Clicking on the menu button will open a new page which list a wide variety of continuing education topics. Clicking on the individual links will open a new document which lists the providers that have informed us of their intention to conduct classes in that particular subject area.

There are currently three providers offering the Well Seal Installation, Protection & Sanitation course. Licensees interested in attending a class should contact the providers below for information on class dates, times, and locations.

#### **Resolution Review Committee Report**

A Field Resolution Agreement is a voluntary agreement by which a licensee enters into some type of sanctions against their license instead of appearing before the Resolution Review Committee or the Full Board at a formal hearing. All of the Agreements are reviewed by a member of the Resolution Review Committee and then presented to a Board hearing panel for approval prior to the agreement being adopted as a final agency decision. If a complaint has not been resolved in the field through a Field Resolution Agreement, then the case can be referred to the Resolution Review Committee. During the Resolution Review Committee meeting, a licensee can enter into a Review Committee Resolution Agreement in place of appearing before the Board at a formal hearing; the agreement is then presented to a Board hearing panel for approval prior to the agreement being adopted as a final agency decision. Cases that cannot be resolved through the use of Field Resolution Agreements or Review Committee Resolution Agreements are forwarded to formal hearings before the Board. Listed below are the different agreements entered into by the field staff and the Resolution Review Committee that have been approved by the Board. The information below does not contain all of the facts or details of each case. #### Bruce, Tradd C. TBA Construction, LLC Union, SC License# 25269, P-I

Allegations of misconduct and incompetence in the business of heating contracting in that the licensee failed to obtain permit(s) prior to commencing work, failed to request inspections within 10 days of substantial completion of work, failed to obtain final inspections, failed to provide supervision, violated the minimum standard of the North Carolina State Plumbing Code, and violated the minimum standard of the North Carolina State Fuel Gas Code.

Resolution Conference held 06/02/2014. Tradd Bruce signed a Resolution Conference Agreement 06/02/2014.

The license of Bruce Tradd, number 25269 P-I, and that of the firm shall be placed on supervised probation for a period of twenty-four (24) months. Among other things, during the probation, the licensee shall assure that all installations that have been performed under his license, that have not been permitted or inspected, shall receive an approved final inspections within thirty (30) days of approval of this agreement, enroll in, attend and complete the series of Special Plumbing Code and Design courses, and enroll in, attend and complete the series of Special Fuel Gas Code and Design courses. In the event of violation of any of the conditions of probation, license of the individual and of the firm will be suspended for a period of twelve (12) months, with the requirement that prior to the suspended license being reinstated the licensee and the firm agrees to comply with all of the probation provisions listed above.

#### Bryant, James Howard Quality Plus Services, Inc. Rocky Mount, NC License# 05650, P-I

Allegations of misconduct and incompetence in the business of plumbing contracting in that the licensee failed to provide adequate supervision for work performed under his license by failing to review or supervise the removal of an existing water heater and the installation of a new 50 gallon electric heater when a permit and inspection were required by NC General Statutes (G.S. 153A-357(a) or 160A-417(a), failed to install a cold water control valve, failed to properly terminate the relief valve drain line, and failed to insulate water piping for the water heater, which was left exposed in an unconditioned space.

James Bryant signed Proposed Resolution Agreement 05/28/2014.

The license of James Bryant, number 05650 P-I, and that of the firm shall be placed on unsupervised probation for a period of twelve (12) months. Among other things during the probationary period, if allowed by the homeowner, the licensee shall obtain a permit, return to this job, correct all code violations and have a final inspection performed by the local inspector by 06/06/2014. After complaint to the board the licensee obtained a permit

and an approved final inspection. Licensee shall enroll in, attend and complete the series of Special Plumbing Code and Design courses, and enroll in, attend and complete the Special Board Laws & Rules course. In the event of violation of any of the conditions of probation, license of the individual and of the firm will be suspended for a period of three months, with the requirement that prior to the suspended license being reinstated the licensee and the firm agrees to comply with all of the probation provisions listed above.

# Carson, Phillp B. Carson and Company, Inc. Bryson City, NC License# S. 10636, P-I

Allegations of misconduct and incompetence in the business of plumbing contracting in that the licensee failed to obtain permit(s) prior to commencing work, failed to request inspections within 10 days of substantial completion of work, failed to obtain final inspections, violated the minimum standard of the North Carolina State Fuel Gas Code, and allowed the use of his license by unlicensed persons by issuing 1099's to unlicensed persons.

Resolution Conference held 06/02/2014. Jimmy Simmons signed a Resolution Conference Agreement 05/29/2014.

The license of Phillip B. Carson, number 10636 P-I, and that of the firm shall be placed on unsupervised probation for a period of twelve (12) months.

Among other things, during the probation, licensee shall submit to the Board's office within 10 days of approval of this agreement copies of all employee W-2's and W-4's for 2013, then by May I, 2015 shall submit to the Board's office copies of all employee W-2's and W-4's for 2014, and then by May I, 2016 shall submit to the Board's office copies of all employee W-2's and W-4's for 2015. Licensee shall enroll in, attend and complete the Special Board Laws & Rules course, and enroll in, attend and complete the series of Special Fuel Gas Code and Design courses. In the event of violation of any of the conditions of probation, license of the individual and of the firm will be suspended for a period of 3 months, with the requirement that prior to the suspended license being reinstated the licensee and the firm agrees to comply with all of the probation provisions listed above.

Cutshall, Craig Willow Creek Hearth & Leisure, Inc. Asheville, NC License# 23721, FP

Allegations of misconduct and incompetence in the business of fuel piping in that the licensee failed to request inspections within 10 days of substantial completion of work, failed to obtain final inspections, failed to provide supervision, and violated the minimum standard of the North Carolina State Fuel Gas Code.

Resolution Conference held 06/03/2014. Craig Daniel Cutshall signed a Resolution Conference Agreement 06/03/2014.

The license of Craig Daniel Cutshall, number 23721 FP, and that of the firm shall be placed on unsupervised probation for a period of twelve (12) months. Among other things, during the probation, licensee shall enroll in, attend and complete the series of Special Fuel Gas Code and Design courses. In the event of violation of any of the conditions of probation, license of the individual and of the firm will be suspended for a period of three (3) months, with the requirement that prior to the suspended license being reinstated the licensee and the firm

agrees to comply with all of the probation provisions listed above.

Allegations of misconduct in the business of heating contracting in that a complaint was filed against the licensee for installation issues for work performed by his firm which included the following: I) High voltage wiring run through return and a portion of the wiring was not in conduit; 2) at three (3) separate job locations, two gas package units were installed (change outs), the required permits were obtained and paid for, but there was no record of the permit or inspections; project was re-permitted and inspections obtained; 3) For four (4) gas package units installed (change-outs) the permit was obtained and the mechanical was inspected; however, the project did not received a final inspection because the equipment needed to be tied in to the alarm system by another firm (fire panel): 4) Kitchen hood exhaust fan installed without a permit, installation performed and permit obtained after work was completed, installation had not received a final inspection because the project was ongoing; however, it was scheduled for a final inspection later on; and failed to obtain final inspections within ten (10) days of substantial completion of the

Paul Catoe signed a Proposed Resolution Agreement 05/02/2014.

The license of Paul I. Catoe, number 29701 H-2, and that of the firm shall be placed on unsupervised probation for a period of twelve (12) months. Among other things, during the probation, the licensee shall enroll in, attend and complete the Board Laws & Rules course. In the event of violation of any of the conditions of probation, license of the individual and of the firm will be suspended for a period of three months, with the requirement that prior to the suspended license being reinstated the licensee and the firm agrees to comply with all of the probation provisions listed above.

Durham, Glenn D. Freeman Gas & Electric Co., Inc. Sylva, NC License# 21182, FP

Allegations of misconduct and incompetence in the business of fuel piping in that the licensee contracted to install fuel piping and (2) freestanding LP gas heaters, during the course of the installation, the licensee failed to pull the required permit for the fuel piping installation in violation of GS 87-21 section .0402, and failed to meet the minimum building code in violation of GS 87-21, section .0505(b) the following code violations were noted by the lackson County Building Inspection Department: I) failed to properly sleeve exterior wall penetration; 2) failed to perform a pressure test; 3) Failed to meet minimum combustible clearance on vent (3/8") for heater in den; 4) failed to meet minimum combustible clearance - insulation against vent in ceiling for heater in bedroom; 5) no paperwork provided for heater (s); and, 6) No shut-off valve for heater in den.

Glenn Durham signed a Proposed Resolution Agreement 04/30/2014.

Among other things, during the suspension, licensee shall enroll in, attend and complete the Special Board Laws & Rules course, and enroll in, attend and complete the series of Special Mechanical Code courses. Upon successful completion of the suspension, the license of Gary Whitener, number 29743 H-3-I, and that of the firm shall be placed on supervised probation for a period of twelve (12) months. In the event of violation of any of the conditions of probation, license of the individual and of the firm will be suspended for a period of six (6) months, with the requirement that prior to the suspended license being reinstated the licensee and the firm agrees to comply with all of the probation provisions.

#### Wooten, David J. Smithfield, NC License# 17627, PH3-I
