### Residential Fire Sprinkler Installation Contractor Course

The Board offers a Residential Fire Sprinkler Installation Contractor (RFSIC) license to those who have held a Plumbing Contractor license with the Board for at least two years. This allows the contractor to install NFPA 13D sprinkler systems in one- and two-family dwellings.

In order to obtain the RFSIC license, the plumbing contractor must do the following:

- submit a completed application to the Board,
- attend and complete the 16 hour course offered by the Board,
- take and pass the examination offered at the end of the class (or at a later date).

The Board is currently attempting to determine the number of plumbing contractors who are interested in obtaining this license. If there are a sufficient number of licensees interested in the course, it will be scheduled in the coming months; however, if there is not sufficient interest the course will not be held.

If you are interested in attending, it is important that you notify the Board as soon as possible, as the decision to hold the class will be made in the upcoming weeks. ### Lead-Safe Exemptions for Restoration Work in Declared Disaster Areas

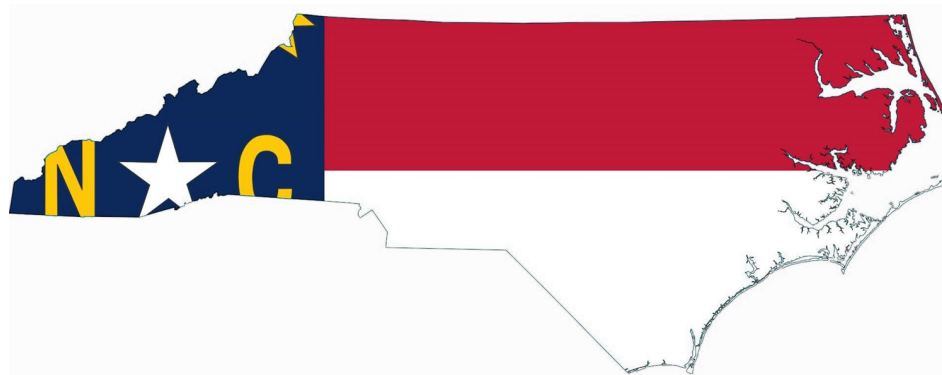

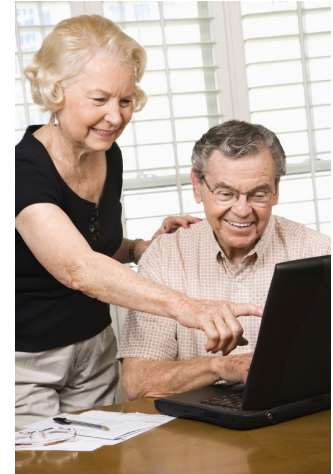

## Disciplinary Actions

The Board is required by law to investigate every complaint received. If the findings of the investigation indicate that a violation of the laws and rules enforced by the Board have occurred by a licensed or unlicensed individual and/or firm, a number of disciplinary actions are available to the Board.

### Letter of Caution Report

Upon completion of investigations, a Letter of Caution can be issued to a licensee where it is determined through an investigation that a violation has occurred by one of our licensees. ### Resolution Agreements

A Field Resolution Agreement is a voluntary agreement by which a licensee enters into some type of sanctions against their license instead of appearing before the Resolution Review Committee or the Full Board at a formal hearing. All of the Agreements are reviewed by a member of the Resolution Review Committee and then presented to a Board hearing panel for approval prior to the agreement being adopted as a final agency decision. If a complaint has not been resolved in the field through a Field Resolution Agreement, then the case can be referred to the Resolution Review Committee. During the Resolution Review Committee meeting, a licensee can enter into a Review Committee Resolution Agreement in place of appearing before the Board at a formal hearing; the agreement is then presented to a Board hearing panel for approval prior to the agreement being adopted as a final agency decision. Cases that cannot be resolved through the use of Field Resolution Agreements or Review Committee Resolution Agreements are forwarded to formal hearings before the Board. Listed below are the different agreements entered into by the field staff and the Resolution Review Committee that have been approved by the Board. The information below does not contain all of the facts or details of each case. Allegations of misconduct and incompetence in the business of heating contracting in that the licensee failed to obtain permits prior to commencing work for several installations that require a license and a permit, failed to request inspections within 10 days of substantial completion of work for several installations that require a license, failed to obtain final inspections for several installations that require a license, failed to provide adequate supervision, failed to carry out adequate ductwork installation and system design, and violated the minimum standard of the North Carolina State Mechanical Code.

Resolution Conference held 08/11/2017.

The license of Michael Arnold, number 19913 H-3-I, and that of the firm shall be placed on unsupervised probation for a period of twenty-four (24) months. Among other requirements during the probation, by 09/30/2017, submit to the board a letter from the homeowner that all of her HVAC issues have been addressed and resolved and that the system is providing her proper comfort. In addition secure a permit for the work that that was performed (prior to 08/11/2017) to address and resolve the cooling/heating issues. Submit a copy of the permit and the final approved inspection. The licensee shall enroll in, attend and complete the series of Special Mechanical Code courses, and the Special Board Laws & Rules course. In the event the licensee violates the conditions of probation, license of the individual and of the firm will be suspended for a period of six (6) months, with the requirement that prior to the suspended license being reinstated, he agreed to comply with all of the probation provisions.

Among other requirements during the probation, licensee shall enroll in, attend and complete the Special Board Laws & Rules course, within twenty (20) days, return to the home located at 509 Smith Street and complete the installation and obtain a final inspection, and within seven (7) days, fill out and complete Trade Name Change form to reflect the way he conducts business. After complaint to the

board, the licensee completed the job and the required trade name change. In the event of violation of any of the conditions of probation, license of the individual and of the firm will be suspended for a period of six months, with the requirement that prior to the suspended license being reinstated the licensee and the firm agrees to comply with all of the probation provisions listed above.

Allegations of misconduct in the business of plumbing contracting in that the licensee, who is a resident of Indiana, worked for a firm in Indiana full time, while plumbing work was contracted and installed in North Carolina while he was actively employed elsewhere, in violation of rule 21NCAC 50.0404(b), violated the minimum standard of the North Carolina State Plumbing Code with plumbing code installation violations, in violation of rule 21NCAC 50.0505(b), failed to provide supervision in that the licensee never appeared onsite to perform proper supervision, in violation of rule 21NCAC 50.0505(a), and failed to notify the Board of a change in address within 30 days as required by rule 21 NCAC50.0408(c).

The Attorney's Report contains information pertaining to cases that have been adjudicated in a formal proceeding of the Board or in the courts of North Carolina. Disciplinary actions against licensed contractors are typically imposed during a Formal Hearing of the Board. Court action is necessary when unlicensed individuals are in violation of the Board's Laws and Rules or in circumstances where licensees are found to be in violation of any order(s) issued by the Board.
