## Dale Dawson Recognized for 25 Years of Service



Board Chairman Jeffrey Dunn recently presented Executive Director Dale Dawson with a plaque bearing a Board Resolution recognizing his 25 years of service with the Board.

Mr. Dawson obtained his Plumbing-Class I license in 1983 and worked full-time in the new and existing residential and commercial plumbing trade for 9 years.

He began employment with the Board on December 1, 1992 as an Administrative Officer assigned to the western region of the state. In 2003, he was named as Senior Administrative Officer and assumed supervisory responsibilities for the field staff of 4, traveling the state extensively in the performance of his duties. During his 14 years in the Administrative Officer capacity, his primary responsibilities included investigations and presenting educational material on behalf of the Board.

In 2006, he was named as Assistant Executive Director and assumed additional management and supervisory responsibilities. In October, 2007, Mr. Dawson was appointed to the position of Interim Executive Director. Following a lengthy selection process, the Board unanimously approved his appointment as Executive Director on April 15, 2008. His experience as both a contractor and Board employee brings a great deal of knowledge and real world experience to the position. As the Executive Director, he is directly involved in the complaint investigations, resolution conferences, formal hearings, educational courses, legal proceedings, application review, examinations, licensing, budgeting, and management of the day-to-day operations of the Board staff. He is also actively involved in maintaining working relationships with a number of industry related officials and organizations in the various trades that the Board is charged with regulating.

Mr. Dawson's business and management philosophy is simple: to operate the Board like a business instead of a bureaucratic governmental agency, and to build a staff of quality employees who are committed to serving the licensees and citizens of our State. As a self-supported Board, funded only by fees charged for licensing and other services, the Board must operate within the limits of an annual budget. Unlike governmental agencies, there is nowhere to go for additional funds if expenses outpace revenues. Guided by those principles since taking charge in 2007, the Board's total assets have increased by 16.52% while the total liabilities have decreased by 25.99%. This puts the Board in a healthy financial position, which in turn helps to keep licensing and processing fees very affordable for applicants, contractors and technicians while maintaining the ability to provide quality services to those who do business with the Board. The use of technologies and streamlined procedures in the office and field has allowed for the reduction of 3 full-time and 5 part-time positions, with an overall improvement in customer service.

Mr. Dawson has also sought to make certain activities more convenient for the licensees of the Board. Resolution conferences, previously only held in Raleigh, are now held at various locations across the state which has eliminated the need for hundreds of licensees to drive to Raleigh. The Laws and Rules class is also provided in both the east and the west, and is free of charge to anyone who wishes to attend. Online renewal is also available for licensees, with plans for more online functionality in the near future.

The Board and staff congratulate Mr. Dawson for a quarter-century of service to the licensees of the Board and the citizens of North Carolina, and look forward to many more years of his expert leadership.

## Have You Renewed Your License for 2018?

### IMPORTANT REMINDER

#### All Board-issued licenses expired on December 31<sup>st</sup>

As of January 15<sup>th</sup>, the Board's records indicated that there were still over 2,500 of approximately 14,000 licensees who have not yet renewed their license for 2018. In other words, over 15 percent of our licensees who are eligible to renew have not yet done so.

If you are among those who haven't yet renewed, your license is currently expired. You (as well as your firm and it's employees) can no longer legally engage in any work which requires a license after that date.

Local inspection departments will check to see if the license is valid before issuing permits, and if the license is expired the permit will not be issued. Code Officials may also issue Stop Work Orders on any jobs that are in progress until the license is renewed, and any licensee or firm who continues to engage in activities requiring a license while expired may face disciplinary action from the Board for doing so without a valid license.

Licenses that expired in 2017 may be renewed during the month of January, 2018 without a late renewal processing fee. Please understand that January is not a "grace period" of any sort for the license. It is simply an opportunity to renew an expired 2017 license without paying a late fee. On February 1, 2018, the late renewal fee of \$25.00 will be added to the renewal fee.

Licenses that expired in 2015 or 2016 may be also be renewed by paying all licensing back fees, and the late renewal fee will apply, even during January. As of January 1, 2018, licenses that expired in 2014 are now in 'Retired' status and cannot be renewed. In order to reinstate a retired license, the individual must reapply to the Board and pass the required examination(s).

Licenses that expired in 2017 may be renewed using our online portal if there are no changes in the trade name or any sub-licensees. Paper renewal forms were mailed to the address of record for all licenses during early October, and contain the Username and Password needed for online renewal. If you wish to renew online and did not receive or have lost your form, you may call our office for assistance. Recent changes to the North Carolina General Statutes regarding employee misclassification have made it necessary for the Board to add an addition requirement to the renewal forms. If submitting a paper form, please make sure that you are using the revised form that contains the following statement under the signature line:

*"By signing this form I attest that all information is correct . I also certify that I have read the Public Notice Statement on the website and that I understand it. I have not been investigated for employee misclassification. If I have been investigated, I have attached the results of the investigation to this renewal form."*

If you wish to renew by paper form and a check or money order, and did not receive or have lost your form, renewal forms may be downloaded from our website and mailed to or brought by our office for processing.

If you did not receive a renewal form by mail, please use the License Search feature on our website to verify that your mailing address is correct. If not, please complete an Address Change Form (also available on the website) and mail, fax, or e-mail it to our office so that your record can be updated with the current and correct information.

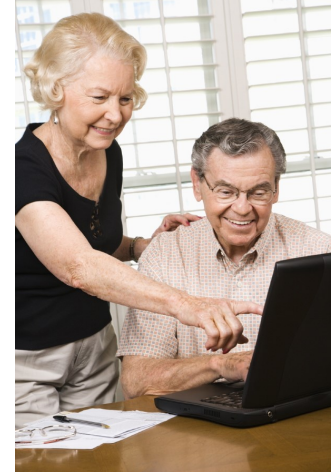

If the findings of the investigation indicate that a violation of the laws and rules enforced by the Board have occurred by a licensed or unlicensed individual and/or firm, a number of disciplinary actions are available to the Board.

### Letter of Caution Report

Upon completion of investigations, a Letter of Caution can be issued to a licensee where it is determined through an investigation that a violation has occurred by one of our licensees. ### Resolution Agreements

A Field Resolution Agreement is a voluntary agreement by which a licensee enters into some type of sanctions against their license instead of appearing before the Resolution Review Committee or the Full Board at a formal hearing. All of the Agreements are reviewed by a member of the Resolution Review Committee and then presented to a Board hearing panel for approval prior to the agreement being adopted as a final agency decision. If a complaint has not been resolved in the field through a Field Resolution Agreement, then the case can be referred to the Resolution Review Committee. During the Resolution Review Committee meeting, a licensee can enter into a Review Committee Resolution Agreement in place of appearing before the Board at a formal hearing; the agreement is then presented to a Board hearing panel for approval prior to the agreement being adopted as a final agency decision. Cases that cannot be resolved through the use of Field Resolution Agreements or Review Committee Resolution Agreements are forwarded to formal hearings before the Board. Listed below are the different agreements entered into by the field staff and the Resolution Review Committee that have been approved by the Board.
