New Online Services Available

Since 2012, licensees have had the option of completing their annual renewal online. This process was recently simplified and implemented for the 2019 renewal cycle, which began in October of last year.

The license search feature has also been available for many years, and website users such as homeowners and inspection departments have been able to verify current licenses. That feature has also recently been enhanced to allow users to find licensees by entering their zip code and a distance in miles. This will allow homeowners to easily search for licensed individuals and firms in their area when in need of their services.

Complaints can now also be filed online by anyone, by providing the basic required information. There are also options to for additional details, including the ability to upload any supporting documents such as invoices or photographs. A link to this feature is on both the Home page and the Complaint page of the website.

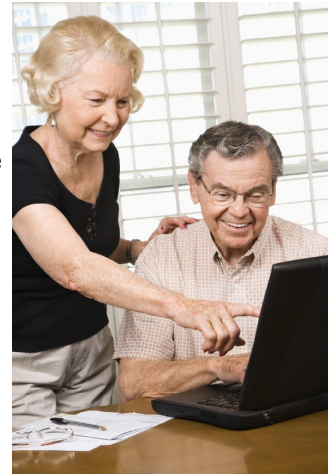

Resolution Agreements

A Field Resolution Agreement is a voluntary agreement by which a licensee enters into some type of sanctions against their license instead of appearing before the Resolution Review Committee or the Full Board at a formal hearing. All of the Agreements are reviewed by a member of the Resolution Review Committee and then presented to a Board hearing panel for approval prior to the agreement being adopted as a final agency decision. If a complaint has not been resolved in the field through a Field Resolution Agreement, then the case can be referred to the Resolution Review Committee. During the Resolution Review Committee meeting, a licensee can enter into a Review Committee Resolution Agreement in place of appearing before the Board at a formal hearing; the agreement is then presented to a Board hearing panel for approval prior to the agreement being adopted as a final agency decision. Cases that cannot be resolved through the use of Field Resolution Agreements or Review Committee Resolution Agreements are forwarded to formal hearings before the Board. Listed below are the different agreements entered into by the field staff and the Resolution Review Committee that have been approved by the Board. The information below does not contain all of the facts or details of each case. The terms of the Proposed Resolution Agreement also included a requirement for the licensee to complete the series of Special Mechanical Code courses and the Special Board Laws & Rules course.

turn to the home located at 3 Ridgewood Place and correct any and all code violations and obtain a final inspection within fifteen (15) days, licensee must complete the series of Special Fuel Gas Code and Design courses and the Special Board Laws & Rules course.

The terms of the Proposed Resolution Agreement also included a requirement for the licensee to complete the series of Special Mechanical Code courses and the Special Board Laws & Rules course.

The terms of the Proposed Resolution Agreement also included requirements for the licensee to assure that all NFPA 25 reports and systems tags reflect the proper Fire Sprinkler Inspection Contract license number and that the Fire Sprinkler Inspection Technician licensee shall sign and affix their license numbers on all NFPA 25 reports and systems tags, assure that all persons who work under his license performing NFPA 25 inspections hold the appropriate active license which license shall be listed under the license of the firms Fire Sprinkler Inspection Contractor's license, and the licensees of the Charlotte and Raleigh offices shall enroll in, attend and complete the Special Board Laws & Rules course.

The license of James Hildebrandt, number 33397 H-3-I, and that of the firm shall be placed on unsupervised probation for a period of twelve (12) months. Among other requirements during the probation, if allowed by the homeowner, within thirty (30) days of the approval of this order the contractor shall return to the homes located at 1541 Turnpike Rd., and perform a thorough Manual J load calculation, Manual D duct design and a Manual S equipment sizing calculations for the lower and upper floors. If the calculations reveal that the equipment or ductwork for either or both floors are improperly sized, then the contractor shall obtain a permit from the local inspection department, replace the improperly sized equipment and ductwork with properly sized equipment and ductwork and obtain a final inspection within sixty (60) days of approval of this order. The contractor shall submit evidence to the board within ten (10) days of the final inspection and shall submit a copy of all of the calculations. In addition, the licensee shall assure that the complete installation for both floors meets or exceeds the minimum standard of the North Carolina State Code. This work shall be performed at no expense to the homeowners. The licensee shall enroll in, attend and complete the series of Special Mechanical Code courses and the Special Board Laws & Rules course. 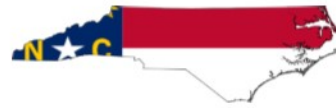
