### **COVID-19 CORONAVIRUS**

As this edition of the newsletter is published, we live in a very different world than we did just two months ago when our last edition was posted. The COVID-19 Coronavirus has affected everyone around the globe, and North Carolina has not been immune to the virus or its effects on our health, our economy, and our freedom to go about our lives as we please. We now must be concerned, and rightly so, about protecting ourselves, our families, our customers, and everyone that we encounter on a daily basis. Masks, gloves, sanitizer, and soap, as well as time and space, have become our weapons as we wage a defensive war against the spread of the virus. With over 14,000 licensees and the employees of their firms, it represents tens of thousands of people working to ensure business continuation during this challenging time.

The Board realizes that this has required a new approach to customer service...things are not "business as usual" anymore. There is a new normal for the time being, and many of the practices that have been devised and implemented during the past two months may need to be continued in the future.

The Board would like to publicly recognize and commend each and every person in the various industries that we serve for the proactive measures that have been taken to ensure that the trade professionals and citizens of our Great State remain safe.

The Board has also been deemed as essential, and has continued to serve our licensees, applicants, and the citizens of North Carolina since the pandemic was declared. Beginning on March 16<sup>th</sup>, our staff began taking measures to ensure that we could continue to serve everyone with the safety of all being a priority. Our lobby was closed to visitors and a plan to allow our office staff members to work from home was put into place. Our field staff was advised to limit contact with others whenever possible, and to purchase personal protective equipment for use when necessary.

Our website has been updated with information regarding COVID-19 measures and new features have been added to allow users to complete more tasks online. Members of our office and field staff are also taking advantage of the technology available to them and conducting most all meetings and interviews via telephone or many of the interactive live platforms available.

Disciplinary education classes, resolution review conferences and formal hearings have been cancelled. For the first time in history, the Board's April business meeting was held online. Weekly virtual staff meetings have been instituted to make sure that everyone on our team is communicating openly and exchanging ideas that benefit our entire staff and all of those that we serve. Extensions have been granted to applicants who were unable to take exams due to the closing of the testing centers and many other smaller adjustments have been made in many areas to deal with the challenges that we continue to face.

The Board members and staff are committed to providing our clients with the highest level of service possible while complying with the required restrictions and recommendations. We will continue to do everything in our power to serve our licensees, applicants, and citizens to the best of our ability.

# Disciplinary Classes Affected by COVID-19 Restrictions

Due to the restrictions on group gatherings, all courses that were scheduled for May or June have either been cancelled or rescheduled. Below is a listing of the changes. The revised schedules for each course may be found by clicking on the Education tab of our website.

**Board Laws & Rules Class** — The classes scheduled for May 6th in Raleigh and May 7th in Statesville have been cancelled. Licensees who were required to attend these classes are expected to attend the next available classes on August 19th in Raleigh and August 20th in Statesville,

**Special Contractor Business Management Course** — The class scheduled for June 24th & 25th has been cancelled. Licensees who were required to attend this course are expected to attend the next available classes on September 23rd & 24th.

**Special Fuel Gas Code & Design Courses** — Session A, originally scheduled for May 30th, has been rescheduled for August 22nd. Session B has been rescheduled for November 21st. Session C will be offered in early 2021.

**Special Plumbing Code & Design Courses** — Session A, originally scheduled for May 9th, has been rescheduled for August 8th. Session B has been rescheduled for November 7th. Session C will be offered in early 2021.

**Special Mechanical Code Course** — Session A, originally scheduled for June 11th, has been rescheduled for September 2nd. Session B has been rescheduled for November 4th Session C will be offered in early 2021

**Special Mechanical Design Course** — The class scheduled for June 17th & 18th has been cancelled. Licensees who were required to attend this course are expected to attend the next available classes on September 9th & 10th.

### Well Seal Installation, Protection & Sanitation Classes Offered

As required by North Carolina General Statute 87-98.4, licensed plumbers who wish to engage in well and pump work but do not hold a Level E certification from the well commission are required to complete the Well Seal Installation, Protection and Sanitation Class within two (2) years prior to engaging in the work.

#### **SECTION 1. G.S. 87-98.4**

#### (b) Exempt persons and activities. - This Article does not apply to any of the following persons or activities:

(13) A person who is licensed as a plumbing contractor under Article 2 of Chapter 87 of the General Statutes who installs pumps or pumping equipment; installs, breaks, or reinstalls a well seal in accordance with G.S. 87-85(6); or disinfects a well incident to the installation, alteration, or replacement of pumps or pumping equipment within or near a well. However, the plumbing contractor shall maintain documentation of having attended a continuing education course that covered well seal installation, protection, and sanitation within the last two years prior to the work being performed. The State Board of Examiners of Plumbing, Heating and Fire Sprinkler Contractors shall ensure that continuing education courses covering well seal installation, protection, and sanitation are available to licensed plumbing contractors during each six-month continuing education course schedule. The licensed plumbing contractor shall remain on-site while the work is being performed until the well is disinfected and sealed."

Plumbing contractors who engage in such work without holding a class completion certificate are subject to discipline by the North Carolina Well Commission.

### **Resolution Agreements**

A Field Resolution Agreement is a voluntary agreement by which a licensee enters into some type of sanctions against their license instead of appearing before the Resolution Review Committee or the Full Board at a formal hearing. All of the Agreements are reviewed by a member of the Resolution Review Committee and then presented to a Board hearing panel for approval prior to the agreement being adopted as a final agency decision. If a complaint has not been resolved in the field through a Field Resolution Agreement, then the case can be referred to the Resolution Review Committee. During the Resolution Review Committee meeting, a licensee can enter into a Review Committee Resolution Agreement in place of appearing before the Board at a formal hearing; the agreement is then presented to a Board hearing panel for approval prior to the agreement being adopted as a final agency decision. Cases that cannot be resolved through the use of Field Resolution Agreements or Review Committee Resolution Agreements are forwarded to formal hearings before the Board. Listed below are the different agreements entered into by the field staff and the Resolution Review Committee that have been approved by the Board.
