Have You Renewed Your License Yet?

Time is running out! 2022 is just over a month away, and all licensees need to renew their license for the upcoming year prior to expiration on December 31st. Failure to renew a license can result in denial of permits and disciplinary action by the Board if work is done on an expired license.

Individuals who hold a currently active license for 2021 are able to renew online for 2022. Renewal notices which contained the username and password in early October. There are three ways to renew.

The preferred method is through the online portal using a MasterCard or Visa. You will need a valid email address to renew online. If you use this method, you should print your license following payment, as a printed copy will not be mailed from the Board's office if the license is renewed online.

The second option is to email or fax the signed renewal form to the Board office, and a link will be sent for online payment. The third option is to mail the signed renewal form to the Board's office with a check or money order. Please note that the renewal will not be processed until payment is received, regardless of the method used.

Licensees who expired in 2018, 2019 or 2020 may renew by submitting a completed paper renewal form and payment (check or money order) to the Board office. You may also email the signed renewal form to dsoltys@nclicensing.org and request a link to pay your fees online. Keep in mind that all forms are processed in the order received and must still be completed PRIOR to 12/31/2021 in order for the license to be renewed successfully. This is not an automated process.

Please note that if the license expired in 2018, it may be renewed until December 31, 2021. After that, the license will be retired, and the individual will be required to take and pass all applicable examinations in order to reinstate the license.

Examination Applications Now Online!

The Board continues to add more online services for applicants, licensees and citizens. In October, we added the ability for applicants to submit their application and supporting documents online. This eliminates the time required for a paper application package to arrive by mail, be processed by our staff, and placed in a stack for review. When submitted electronically, the application is received and processed faster, and can be reviewed electronically.

There are a few things of importance with the online application process. Applicants must have the ability to upload their supporting documents (experience verification forms, W2s/1099s, and other documents that may be required). They must also have a valid e-mail address that is checked regularly. Documents that require a signature and/or notarization may be uploaded for the review process, but final approval of the application and exam scheduling will not be completed until the original signed and/or notarized documents are received and processed in our office.

Once the application is reviewed, approved, and all required original documents have been received and processed, the applicant will receive an email notification of the approval and instructions for scheduling the required exam(s).

Resolution Agreements

A Field Resolution Agreement is a voluntary agreement by which a licensee enters into some type of sanctions against their license instead of appearing before the Resolution Review Committee or the Full Board at a formal hearing. All of the Agreements are reviewed by a member of the Resolution Review Committee and then presented to a Board hearing panel for approval prior to the agreement being adopted as a final agency decision. If a complaint has not been resolved in the field through a Field Resolution Agreement, then the case can be referred to the Resolution Review Committee. During the Resolution Review Committee meeting, a licensee can enter into a Review Committee Resolution Agreement in place of appearing before the Board at a formal hearing; the agreement is then presented to a Board hearing panel for approval prior to the agreement being adopted as a final agency decision. Cases that cannot be resolved through the use of Field Resolution Agreements or Review Committee Resolution Agreements are forwarded to formal hearings before the Board. Listed below are the different agreements entered into by the field staff and the Resolution Review Committee that have been approved by the Board. Among other requirements during the probation, licensee shall enroll in, attend, and complete the Special Board Laws & Rules course.

Brackett, Jesse DMC Renovations d/b/a Bath Pro **Richfield**. NC License# 29367 P-I

Allegations licensee was actively employed fulltime for Queen City Plumbing while licensing Pipez, Inc. DBA All About the Pipes Plumbing while they were performing plumbing work that required a license, and license failed to provide supervision.

Resolution Conference held 07/12/2021.

The Review Committee found that the allegations were supported by the evidence and recommended that the license of lesse firm shall be placed on unsupervised probation for a period of twenty-four (24) months. Among other requirements during the probation, licensee shall never place his license in the name of a firm unless he is a fulltime employee of the firm or the owner of the firm and complete the Special Board Laws & Rules course.

The Review Committee found that the allegations were supported by the evidence and recommended that the license of Robert Bustle, number 30183 H-1,2&3-l, and that of the firm shall be placed on supervised probation for a period of eighteen (18) months. The licensee shall enroll in, attend, and complete the Special Board Laws & Rules course and the licensee shall enroll in, attend, and complete the series of Special Mechanical Code courses.

Canaday, Jonathan Canaday's Plumbing Four Oaks, NC License# 20636 P-I

Allegations the licensee failed to comply with the bona-fide employee rule 2I NCAC 50.0512.

Jonathan Canady signed a Proposed Resolution Agreement 08/04/2021.

The Review Committee found that the allegations were supported by the evidence and recommended that the license of Jonathan Canaday, number 20636 P-I, and that of the firm shall be placed on an unsupervised probation for a period of twelve (12) months. The licensee shall enroll in, attend, and complete the Special Board Laws & Rules course and submit to the Board's office within the next thirty (30) days copies of all employee W-4's and by the end of the probation submit a copy of all employee W-2's.

Canady, Thurman Jr. Canady's Heating & Air Conditioning, LLC Clayton, NC License# 33452 H-3-I

Allegations the licensee allowed the use of for a period of twenty-four (24) months. the licensee received \$150.00 per permit for CMC Electrical. LLC to contract and perform gas piping for new generator installations and allowed the use of license by unlicensed persons by issuing 1099's to unlicensed persons.

Resolution Conference held 08/23/2021. The Review Committee found that the allegations were supported by the evidence and recommended that the license of Thurman Canady, number 33452 H-3-I, and the license of the firm be suspended for a period of six (6). Among other requirements during the suspension, the licensee shall enroll in, attend, and complete the Special Board Laws & Rules course. Upon successful completion of the suspension, his license, number 33452 H-3-I, and that of the firm shall be placed on supervised probation for a period of eighteen (18) months.

Clayton, Thomas Clayton Heating & A/C Burlington, NC License# 13445 H-2&3-1

Allegations the licensee violated probation. Resolution Conference held 08/17/2021.

The Review Committee found that the allegations were supported by the evidence and recommended that the license of Thomas Clayton number 13445 H-2&3-I, and the license of the firm be suspended for a period of six (6) months. Among other requirements during the suspension, the licensee shall enroll in, attend, and complete the Special Board Laws & Rules course and the licensee shall enroll in, attend, and complete the series of Special Mechanical Code courses. Upon successful completion of the suspension, his license, number 13445 H-2&3-I, and that of the firm shall be placed on supervised probation for a period of twenty-four (24) months.

Dudley, Aaron C. Dudley Heating & Air, LLC Kenly, NC

License# 34363 H-3-I

Allegations the licensee failed to obtain permit(s) prior to commencing work, failed to provide adequate supervision, violated the minimum standard of the North Carolina State Mechanical Code, allowed the use of license by unlicensed persons by issuing 1099's to unlicensed persons, and violated a Letter of Caution agreement that the licensee never attend the Board Laws and Rules Class.

Resolution Conference held 07/23/2021.

The Review Committee found that the allegations were supported by the evidence and recommended that the license of Aaron Dudley, number 34363 H-3-I, and that of the firm shall be placed on supervised probation

the license by CMC Electrical, LLC where Among other requirements, the licensee shall also enroll in, attend, and complete the Special Board Laws & Rules course and the series of Special Contractor Business Management courses approved by the Board's Executive Director within 90 days of approval of this agreement.

Edwards, Barry Air Comfort Company, Inc. Greensboro, NC

License# 31849 H-3Technician

Allegations the licensee violated the Letter of Caution signed by the licensee on October I, 2019 by failing to attend the Board's Laws and Rules Class, failed to provide evidence to the board that the issues with the work performed under complaint file number 2019-417 has been resolved, and the licensee acknowledged that the master licensee and the holder of the contractor license for the firm, Barry M. Edwards license number 10285 H-2&3-I, only works for the firm about 5 hours a week, picking up and delivering materials.

Resolution Conference held 07/23/2021.

The Review Committee found that the allegations were supported by the evidence and recommended that the license of Barry Edwards, number 31849 H-3Technician, and that of the firm shall be placed on unsupervised probation for a period of twelve (12) months. Among other requirements, the licensee, within 10 days of approval of this agreement, the licensee shall submit detailed documentation to the board to demonstrate that the issues with the job in complaint file number 2019-417 has been completely resolved. Within seven (7) months of approval of the agreement the license, Barry M. Edwards, Ir., shall make application to and sit for the Heating Group 3, Class I Examination at least two times. If the applicant passes the examination on the first try, then there would not need to take the examination the second time. The licensee shall also enroll in, attend, and complete the Special Board Laws & Rules course.

License# 00000, owner/operator

Allegations the licensee operated the firm during the follow times when the firm was not licensed: on or about December 18, 2018, through July 8, 2019, on or about September 29, 2020, through October 5, 2020, pulled permits under licensee's licenses when the licensees were either no longer employees or before the licensees actually listed their license in the name of the firm.

Resolution Conference held 07/21/2021.

The Review Committee found that the allegations were supported by the evidence and recommended that the license of the firm, firm shall be placed on supervised probation for a period of thirty-six (36) months. Mary Geiger shall enroll in, attend, and complete the Special Board Laws & Rules course.

Guzman, Obed Alma HVAC Inc. Charlotte, NC License# 27497 H-1,2&3-I

Allegations the licensee allowed the use of the license on a permit for a job that the licensee did not contract the work, did not supervise the work, his employees did not perform the work and he did not receive the contractual payments.
