PUBLIC RULEMAKING HEARINGS

June 9, 2009 at 8:30 a.m.

1109 Dresser Ct., Raleigh, NC 27609

The Board is holding a hearing to solicit input on proposals which would (a) create a licensure category for residential fire sprinkler contractor; (b) modify the experience prerequisite for examination so as to allow a broader range of activity to count as experience; (c) consider elimination of a Board requirement of permit and inspection for replacement of electric residential hot water heaters in some circumstances; (d) clarify contractor obligation during separate employment; (e) make cosmetic and grammatical changes without anticipated impact; (f) clarify the performance standard for HVAC systems installed by licensees and (g) cost of living adjustment of fees.

The public hearing will start at 8:30 am on June 9, 2009 at the Board office (1109 Dresser Ct., Raleigh, NC). The proposed rules are currently available for review at the board's web site (www.nclicensing.org). Any person desiring to present oral data, views, or arguments on the proposed rule is asked to advise the Board at least 10 days prior to the hearing. Any person who makes an oral presentation is encouraged to submit a written copy of the presentation to the Executive Director prior to or at the hearing.



Licenses That Expired On December 31, 2006

In order to avoid re-examination, the Board requires that all licenses expired on December 31, 2006 must have fees paid through 2009, 18 hours of continuing education obtained (4 of which must be in code changes and amendments) and the appropriate form **completed and received correctly no later than December 31, 2009**. General Statutes 87-22 provides in part "...the Board requires re-examination upon failure of a licensee to renew license within three years after expiration."

Board Rule 21NCAC50.0409 REINSTATEMENT OF EXPIRED LICENSE – A license which expires may be reinstated within three years of the date of expiration upon written request and upon payment of the current license fee, the license fee for the unpaid prior years together with the processing fee impose by GS 87-22.

Continuing Education Corner

Each year the Board publishes two newsletters, which are designed to keep licensees informed of the activities of the Board and information which may be helpful to the licensees. In the past, both of the newsletters have included the Continuing Education Schedules (January-June and July-December).

As the Board continues to explore new ways to operate in a more cost-effective manner, the newsletter will no longer contain the printed CE schedules. This single change will save the Board thousands of dollars each year in printing and postage costs, and will also benefit the environment by using considerably less paper.

The CE schedule is published on the Board website (www.nclicensing.org), and may be viewed by clicking on the "C.E. Classes" tab. You may also print the schedule if necessary.

A much faster and more convenient way to locate classes is to use the search feature on the C.E. Classes webpage, which will allow you to find classes listed by date range, license type, location, provider, and instructor. By using one or more of the search functions, you can view a wide variety of classes or narrow the results to just a few.

If you do not have internet access at your home or office, most public libraries have computers available for your use, and the staff should be willing to assist you if needed.



In addition, the course providers routinely mail fliers to licensees containing information about upcoming classes that may be of interest.

Licensees Required to Bring Code Books to Continuing Education Classes!

Licensees are required to have the latest versions of all pertinent code books at all code related CE classes associated to the classification of license they hold. Plumbing classes would require the North Carolina Plumbing Code, North Carolina Accessibility Code and/or the North Carolina Fuel Gas Code. Mechanical classes would require the North Carolina Mechanical Code, North Carolina Energy Code and/or the North Carolina Fuel Gas Code. Fuel Gas classes would require the North Carolina Fuel Gas Code. Prior to attending class, the licensee will need to verify with the course provider which code book(s) are required for that specific course.

If a licensee does not have the appropriate code book(s), they should check with the course provider to see if the code book(s) will be available for purchase at the class location. Code book(s) can also be purchased through the Department of Insurance at (919)661-5880.



Consent Agreement Report

A Consent Agreement is a sworn affidavit taken from unlicensed individuals who have contracted or performed plumbing, heating, air conditioning, fuel piping or fire sprinkler work without a license. These individuals sign a Consent Agreement stating that they will not perform any work requiring a license until they are properly licensed to do so. If you see these individuals in the field contracting or installing work that requires a license, please report them to this office.

Boiler Code Book

Effective August 15, 2007 anyone taking the Heating, Group 1, Class I examination will no longer be allowed to use their copy of the Uniform Boiler and Pressure Vessel Act published by the Department of Labor, Boiler and Pressure Vessel Division. This publication is available to download from the Department of Labor. To secure the creditability of the publication each test site will provide copies to be used by the applicant while testing. If taking the Heating, Group 1, Class I examination check with the proctor prior to entering the exam area.

Permit Warning Letters

A Permit Warning Letter is issued to licensees who have been found to have performed plumbing, heating, air conditioning, fuel piping or fire sprinkler work without a permit having been issued prior to the commencement of the work. Section .0402(a) of the Laws and Rules book states in part that “A licensed contractor shall assure that a permit is obtained from the local Code Enforcement Official before commencing any work for which a license is required by the Board.” If you have questions concerning permits, contact your local inspection office. If it is found that multiple jobs have been performed without first obtaining permits, the Board may take additional disciplinary action against the individual and firm. The following individuals were issued permit warning letters for failure to assure a permit was obtained prior to commencing work:

Field Resolution Agreements and Resolution Review Committee Agreements

A Field Resolution Agreement is a voluntary agreement by which a licensee enters into some type of licensing sanctions against their license in place of appearing before the Resolution Review Committee or the Full Board at a formal hearing. All of the Agreements are reviewed by a member of the Resolution Review Committee and then presented to a Board hearing panel for their approval prior to the agreement being adopted as a final agency decision. If a complaint has not been resolved in the field through a Field Resolution Agreement, then the case can be referred to the Resolution Review Committee. During the Resolution Review Committee meeting, a licensee can enter into a Review Committee Resolution Agreement in place of appearing before the Board at a formal hearing; the agreement is then presented to a Board hearing panel for their approval prior to the agreement being adopted as a final agency decision. Cases that cannot be resolved through the use of Field Resolution Agreements or Review Committee Resolution Agreements are forwarded to formal hearings before the Board. Listed below are the different agreements entered into by the field staff and the Resolution Review Committee that have been approved by the Board. The information below does not contain all of the facts or details of each case, but specific details of any of the following cases can be obtained by e-mail (information@nclicensing.org) or upon written request to the Board's office.

In response to requests from Board staff, the Respondent carried out several actions including: (a) completely replaced the return; (b) straightened the supplies and removed them from the catwalk; (c) sealed the takeoffs, boots and sheet metal seams; (d) completed a load calculation and provided it to Board staff; and (e) borrowed the New Hanover County Inspection Department flow hood, balanced the system which improved airflow. The Resolution Committee of the Board directed this matter to be heard before the Board due to the absence of resolution of the issues surrounding maintenance of required design temperature throughout the dwelling. The Board found that in the absence of more demanding contractual obligations, systems in the Leland area of North Carolina are required to hold inside temperatures at 75 degrees, during the cooling cycle, at any outside temperature of 91 degrees or below. The choice of the property owner to set the thermostat at a temperature lower than 75 degrees during the cooling season has the effect of adding additional cooling to the lower floor by depriving the upper floor of cooling, the opposite of the result desired by the property owner. The lack of insulation in some parts of the attic or adjacent to the bonus room contributed to, but was not the sole cause of the failure of the system to hold temperature. The evidence is ample to support a finding here that, at the maximum outside design temperature of 91 degrees, the system will not maintain a 75 degree temperature in the house. The evidence before the Board was not sufficient to establish that, at the 91 degrees design temperature, the system will not maintain the temperature within a 4 degree range throughout the dwelling. Accurate outside temperature readings are an important part of calculation of performance at or near the design maximum temperature. Room by room heat loss/heat gain calculations carried out after the fact, demonstrated that the equipment was somewhat undersized.

The Board ruled that the standard of competence in North Carolina includes a room-by-room heat loss/heat gain calculation in all new construction and a whole house heat

loss/heat gain calculation in replacement installations.
