Urgent & Important Information for Fire Sprinkler Inspection Contractors

NFPA 25 requires the annual inspection of fire sprinkler systems, and the inspections must be contracted and performed by a firm who holds an active Fire Sprinkler Inspection Contractor license from the Board. Unfortunately, some contractors are not ensuring that the inspections are being performed properly, especially with regard to the requirement that every sprinkler head be inspected unless a valid exemption exists. Being unable to access a tenant space is not a valid exemption. Contractors must work with the property owner in advance to ensure that all tenant spaces are accessible when the inspection is performed. The Board has issued an interpretation regarding this matter, which is on Page 3 of this newsletter and is also available on the Interpretations page of our website.

New Laws Provide for 'Timely Inspections'

The General Assembly recently made changes to G.S. 143-139.4, which allows building permit holders to request assistance from the North Carolina Department of Insurance if a local inspection department is unable or unwilling to conduct a requested inspection within a 'reasonable' time. In response to this, NCDOI has provided means of doing so via their website. The new button is labeled "File a Complaint on Inspections Department – Timely Inspections" and will allow the user to enter information on the online form and submit supporting documentation via email. You may visit the page by clicking here.

Contractors are urged to take time to read the General Statue in its entirety before using the reporting option, and can access the full document by clicking here.

Here are a few important points to remember. An inspection department has two business days following the request to provide the inspection. Requests received after 12:00 noon will be considered as being received the following day. Weekends and holidays cannot be counted as business days. The option may be used only if an inspection department has failed to perform, or informs the permittee that they will not be able to perform, the requested inspection within the allotted timeframe, and the request must contain all of the required documentation regarding the permit and inspection request.

NC and SC Boards add Commercial Licensing to Existing Technical Exam Waiver Agreement

The North Carolina State Board of Examiners of Plumbing, Heating and Fire Sprinkler Contractors and the South Carolina Contractor's Licensing Board have entered into partial examination waiver agreements for licensees who hold licenses obtained by examination in either state. The agreements exempt a currently licensed contractor from the technical portion of the contractor examinations when applying for licensure in their neighboring state. The applicant is still required to take and pass the business law examination of the state that is being applied for. Fire Sprinkler Inspection Interpretation (continued from Page 1)

INTERPRETATION: NFPA 25 Fire Sprinkler Inspections

Issued: August 11, 2022

The State Board of Examiners of Plumbing, Heating and Fire Sprinkler Contractors has been made aware that some firms engaged in the business of fire sprinkler inspection contracting are not performing their annual fire sprinkler inspections in compliance with the requirements prescribed by the National Fire Protection Association (NFPA) as incorporated into the North Carolina State Building Code.

The primary issue of concern is the failure of inspection contractors/technicians to properly conduct inspections in accordance with the requirements of NFPA 25, particularly in residential occupancies such as apartments, condominiums, hotels, and similar occupancies.

Fire Sprinkler Inspection Contractors, Fire Sprinkler Inspection Technicians, and owners of firms engaged in contracting and/or performing such inspections should understand that this is a matter of life safety. Failure to properly conduct inspections in accordance with the requirements of NFPA 25, the North Carolina State Building Code, and the rules of the State Board of Examiners of Plumbing, Heating and Fire Sprinkler Contractors will result in disciplinary actions by the Board. In addition, doing so may also expose those responsible to civil litigation and possible criminal prosecution if failure to properly conduct inspections is found to be a contributing factor after a fire results in property damage, personal injury, or death.

The 2014 edition of NFPA 25 provides the following requirements and guidance.

Chapter 4 sets forth the following applicable section:

Section 4.1.3 states: "The property owner or designated representative shall provide ready accessibility to components of water-based fire protection systems that require inspection, testing, and maintenance "

Chapter 5 sets forth the following sections that are applicable:

Section 5.1.1.1 states: "This chapter shall provide the minimum requirements for the routine inspection, testing, and maintenance of sprinkler systems."

Section 5.2.1.1 states: "Sprinklers shall be inspected from the floor annually."

Section 5.2.1.1.2 states: "Any sprinkler that shows signs of any of the following shall be replaced:

- Leakage
- Corrosion
- Physical damage
- Loss of fluid in the glass bulb heat-responsive element
- Loading
- Painting unless painted by the sprinkler manufacturer

Section 5.2.1.1.3 states: "Any sprinkler that has been installed in the incorrect orientation shall be corrected by repositioning the branch line, drop or sprig, or shall be replaced."

Section 5.2.1.1.4 states: "Sprinklers installed in concealed spaces such as above suspended ceilings shall not require inspection"

Section 5.2.1.1.5 states: "Sprinklers installed in areas that are inaccessible for safety considerations due to process operation shall be inspected during each scheduled shutdown."

Taken together, the above sections speak to the requirement to perform visual inspections from the floor of ALL sprinkler heads, unless the exceptions for concealed spaces or inaccessibility for safety considerations are applicable. Licensees should understand in the event of a complaint to the board they will be held to compliance to the standard set out in NFPA 25.

It should be noted that additional inspections may be appropriate, this document is only intended to address the annual inspection per NFPA 25.

21 NCAC 50 .0403 is proposed for amendment as follows:

21 NCAC 50 .0403 USE OF LICENSE

- (a) A licensed contractor or technician shall not permit the use of his license by any other person.
- (b) A contractor licensed by the Board shall not bid or contract installations requiring license of a type or classification issued by this Board which the licensee does not have except as a part of a documented joint venture with a licensee holding the necessary qualification or in accordance with the provisions set out in 21 NCAC 50 .0415. Bidding without qualification and with an intention to subcontract the unauthorized work does not satisfy this requirement; provided however that, in a contract administered pursuant to G.S. 143-129 and in which more than one classification administered by this Board has been combined in the separate contract specifications, a licensee of this Board holding either of such qualifications may bid both of such classifications of work administered by this Board in addition to the classification for which he holds license if the successful bidder obtains an executed written contract with a qualified licensee prior to the award of the contract by the awarding authority.
- (c) A technician licensed by this Board shall not contract work based on the Technician license.

21 NCAC 50 .0415 is proposed for adoption as follows:

21 NCAC 50.0415 PROPOSAL, BID, ESTIMATE, PERFORMANCE UNDER G.S. 87-1.1

If a building project is bid or performed pursuant to G.S. 87-1.1,

- (1) the total amount of work to be performed by all licensed general contractors shall not exceed 25% of the total bid price;
- (2) the total amount of work to be performed by all licensed contractors issued a license by the State Board of Examiners of Electrical Contractors under Article 4 of Chapter 87 of the North Carolina General Statutes shall not exceed 25% of the total bid price.

21 NCAC 50 .0519 is proposed for amendment as follows:

21 NCAC 50 .0519 RESIDENTIAL FIRE SPRINKLER DESIGN CONTRACTOR LICENSE

- (a) A licensed Residential Fire Sprinkler Design Contractor is authorized to design residential fire sprinkler Systems consistent with NFPA 13D Residential Multipurpose Fire Sprinkler Systems.
- (b) An individual who holds an active license as a Plumbing Contractor and as a Residential Fire Sprinkler Installation Contractor may obtain license as a Residential Fire Sprinkler Design Contractor upon meeting the requirements of Rule .0316 of this Chapter.
- (c) A licensed Fire Sprinkler Installation Contractor may design residential fire sprinkler systems consistent with NFPA I3D Residential Multipurpose Fire Sprinkler Systems without meeting the requirements of Paragraph (a) and (b) of this Rule.
- (d) Residential Fire Sprinkler Design Contractors shall place their Residential Fire Sprinkler Design Contractor license number and their dated signature on all design drawings and documents.
- (e) Residential Fire Sprinkler Design Contractors shall submit all NFPA 13D multipurpose fire sprinkler design drawings and documents to the Residential Fire Sprinkler Installation Contractors prior to the commencement of the multipurpose fire sprinkler installation and upon request from the local inspection department.

21 NCAC 50 .0520 is proposed for adoption as follows:

21 NCAC 50 .0520 ONSITE SUPERVISION AND STANDARD OF COMPETENCE

General supervision requires that a licensee of the firm who holds the proper licensing qualification shall personally perform on-site in-person supervision and review on all work, prior to work being covered or placed into service, to assure that all installations meet or exceed the minimum standard of the North Carolina State Building Code prior to all inspection requests.

21 NCAC 50 .1101 is proposed for amendment as follows:

21 NCAC 50 .1101 EXAMINATION FEES

- (a) An application to reissue or transfer a license to a different corporation, partnership or individual name requires a fee of twenty-five dollars (\$25.00).
- (b) An application to issue or transfer a license to the license of an existing licensee requires a fee of twenty-five dollars (\$25.00).
- (c) An application for a license by examination requires a fee of one hundred dollars (\$100.00), consisting of an application fee of twenty-five dollars (\$25.00) and an examination fee of seventy-five dollars (\$75.00), which is nonrefundable. Upon passage of the examination, the license fee set forth in 21 NCAC 50.1102 or this Rule must be paid to obtain the license within 45 days of notification of the result of the examination, except that anyone passing the examination on or after November October I of any year may elect to obtain a license for the following year rather than the year in which the exam was passed.

An individual who holds any of the following qualifications obtained by examination from South Carolina and wishes to obtain the equivalent North Carolina license may submit a Plumbing / Heating Contractor application and South Carolina Exam Waiver (both available on the Forms page of our website at https://nclicensing.org/forms.asp). However, the applicant must still take and pass the business law portion of the North Carolina exam before becoming licensed.

Annual License Renewals to Begin in October

2023 is only four months away, and all licensees need to renew their license for the upcoming year prior to expiration on December 31st. Failure to renew a license can result in denial of permits and disciplinary action by the Board if work is done on an expired license.

Beginning October 1, 2022, individuals who hold a currently active license for 2022 will be able to renew online for 2023. Renewal invoices will be issued in early October, through U.S. Mail and emailed to all licensees who have valid email addresses on file with the Board.

There are three ways to renew. The preferred method is through the online portal using a MasterCard or Visa. You will need a valid email address to renew online. If you use this method, you should print your license following payment, as a printed copy will not be mailed from the Board's office if the license is renewed online.

The second option is to email or fax the signed renewal form to the Board office, and a link will be sent for online payment. The third option is to mail the signed renewal form to the Board's office with a check or money order. Please note that the renewal will not be processed until payment is received, regardless of the method used.

Licensees who expired in 2019, 2020, or 2021 may renew by submitting a completed paper renewal form and payment (check or money order) to the Board office. You may also email the signed renewal form to dsoltys@nclicensing.org and request a link to pay your fees online. Keep in mind that all forms are processed in the order received and must still be completed PRIOR to 12/31/2022 in order for the license to be renewed successfully. This is not an automated process.

Please note that if the license expired in 2019, it may be renewed until December 31, 2022. After that, the license will be retired, and the individual will be required to take and pass all applicable examinations in order to reinstate the license.

Consent Agreement Report

A Consent Agreement is an affidavit taken from unlicensed individuals performing plumbing, heating and fire sprinkler work without a license. These individuals sign a Consent Agreement stating that they will not perform any work requiring a license until they are properly licensed to do so. If you see these individuals performing con-

Resolution Agreements

A Field Resolution Agreement is a voluntary agreement by which a licensee enters into some type of sanctions against their license instead of appearing before the Resolution Review Committee or the Full Board at a formal hearing. All of the Agreements are reviewed by a member of the Resolution Review Committee and then presented to a Board hearing panel for approval prior to the agreement being adopted as a final agency decision. If a complaint has not been resolved in the field through a Field Resolution Agreement, then the case can be referred to the Resolution Review Committee. During the Resolution Review Committee meeting, a licensee can enter into a Review Committee Resolution Agreement in place of appearing before the Board at a formal hearing; the agreement is then presented to a Board hearing panel for approval prior to the agreement being adopted as a final agency decision. Cases that cannot be resolved through the use of Field Resolution Agreements or Review Committee Resolution Agreements are forwarded to formal hearings before the Board. Listed below are the different agreements entered into by the field staff and the Resolution Review Committee that have been approved by the Board. The information below does not contain all of the facts or details of each case. Beese, William C/A Heating & Air Conditioning, Inc. New Bern, NC

License# S. 29425 H-1,2&3-I

Allegations that licensee failed to obtain permit(s) prior to commencing work, failed to request inspections within 10 days of substantial completion of work, failed to provide adequate supervision, violated the minimum standard of the North Carolina State Mechanical Code, failed to provide load calculation upon request from the homeowner, failed to maintain a copy of the load calculation for a minimum of 6 years, the contractor stated that data was lost with a crash of a computer, and provided conflicting load calculations on a job where the contractor removed 6 total tons of cooling and replaced it with 7.5 tons of cooling.

Resolution Conference held 05/25/2022.

The Review Committee found that the allegations were supported by the evidence and recommended that the license of the license of William Beese, number 29425 H-1.2&3-I. and that of the firm shall be placed on unsupervised probation for a period of eighteen (18) months. Among other requirements during the probation, the licensee shall enroll in, attend, and complete the complete the series of Special Mechanical Code courses and complete the series of Special Mechanical Design courses.

Drew, Richard d/b/a One Hour Heating & Air Conditioning Ocean Isle Beach, NC License# 13497 H-3-I

Allegations the licensee improperly operated in an illegal business name as they are currently operating as Carolina Home Service Group, Inc. DBA Myrtle Beach's One Hour Heating & Air Conditioning, yet the license is only listed as Carolina Home Service Group, Inc. failed to obtain permit prior to commencing work, failed to request inspections within 10 days of substantial completion of work, failed to obtain final inspection, failed to provide adequate supervision, failed to carry out adequate ductwork installation, violated the minimum standard of the North Carolina State Mechanical Code, upselling a UV light that was not needed, and failed to perform work in compliance with the written contract with the homeowner (Aeroseal was not fully applied to seal the ductwork). Resolution Conference held 05/24/2022.

The Review Committee found that the alle- Allegations licensee failed to provide supervigations were supported by the evidence and recommended that the license of Richard Drew, number 13497 H-3-I, and that of the firm shall be placed on supervised probation for a period of twenty-four (24) months. Among other requirements during the probation, licensee shall enroll in, attend and complete the Special Board Laws & Rules course and complete the series of Special Mechanical Code courses.

Hough, Ronald C. Preston Heating, Cooling & Electrical, LLC. Monroe, NC License# 11037 H-2&3-I
