Some licensees might wonder what the Board has to do with whether or not a licensee pays his child support. A licensee found that out just this week when he received a letter from the Board that said:

"Pursuant to G.S. 110-142-1 your license with the State Board of Examiners for Plumbing, Heating and Fire Sprinkler Contractors is hereby revoked/suspended. You may apply for reinstatement when this non-compliance has been corrected."

If you have state ordered child support and fail to pay, the law requires that your license be revoked/suspended. We will be notified that you have failed to pay and then we'll send you a certified letter telling you that a Field Investigator will be by to pick up your license.

In addition as employers you may be required to deduct court ordered child support payments from an employee's wages or salary. This evolved into a somewhat burdensome process for employers who were required to make payments to various Clerks of Courts throughout the state.

The North Carolina General Assembly has revised the system to simplify the process for everyone.

Since October 1, 1999 all child support payments in North Carolina have been collected at one central location – the NC Child Support Centralized Collections. This new system is designed to simplifying the process, improving the speed and accuracy of child support collections and distribution. This change will benefit employers who in the past may have had to mail checks to various Clerks of Court.

All employers who deduct child support payments must now forward the payment to the following address: NC Child Support Centralized Collections, P.O. Box 90012, Raleigh, North Carolina 27675-9012. If you have any questions regarding Centralized Collections, please feel free to call: 1-800-531-1818. You can also contact your local child welfare agency for further information.

Will you get the job?

This a list of items a home ⁴. owner or business owner should ask themselves before hiring you. Check it off and see if you'd get the job if they did these things. 5. If not, you need to make some changes in what you are doing.

Do your homework before you have work done on your home. Don't hire just any contractor to do your plumbing-heating-cooling work. Use this checklist to select a professional who you can trust with your most valuable asset. 7.

- Does the contractor have a license? Check with your local Consumer Affairs Department to see if a license is required in your community. Most communities have some licensing requirements to ensure plumbing codes are followed.
- How long has the contractor been in business? The longer the better - usually. It typically takes three to five years to establish a financially sound business.
- Have you called the Better be all about Business Bureau? They can expensive. alert you to any outstanding complaints.

- Can the contractor show proof of workers compensation and general liability insurance? If not, you would be liable for any construction-related accidents on your premises.
- Ask to see a list of references and call them. Would they hire the same contractor again?
- Will the contractor provide a clearly written estimate and contract? Get everything in writing; the more professionallooking, the estimate and contract, the better.
 - What are the contractors problem-solving policies? Are guarantees offered on the work and the products used? All policies should be listed in the contract.
 - Does the contractor belong to any professional organizations? Although it is no guarantee of the quality of a contractors work, it may tell you something about the contractors commitment to the industry and profession.

Consent Agreement Report

This list will run several times in hope that if they show up in your area and continue to work unlicensed you will report them.

A Consent Agreement is an affidavit taken from unlicensed individuals performing plumbing, heating and fire sprinkler work without license. These individuals sign a Consent Agreement stating that they will not perform any work requiring a license until they are properly licensed to do so. If you see these businesses or individuals in the field report them to this office.

We are fast approaching renewal season and if your correct address in not in the file you may end up paying additional charges such as late fees. Look on this newsletter and verify that the address is correct, if not notify us immediately. <u>You</u> are responsible for your license renewal not anyone else.

CHANGE OF ADDRESS

The Board's rule, 21 NCAC 50.0408 (c) reads as follows:

(C) The licensee shall notify the Board of any change in location or mailing address from that shown on the last license renewal invoice within 30 days after the change takes place.

The above rule requires you to notify the Board of a change of address within 30 days after the change takes place. Compliance with this rule benefits you and the Board. The Board is able to keep its records up to date if you notify the office of an address change. The Board is also able to keep you up to date if it has your correct address. Through the newsletter, the Board notifies you of new requirements for licensed contractors, code amendments, educational opportunities, public rule hearings that may affect you, and much more. The newsletter will not get to you if the Board does not have your correct address. The Board notifies you an invoice. This invoice will not get to you if the Board does not have your correct address.

Changes must be in writing with your signature. Many an ex-relative or business partner has forwarded mail to Alaska without permission.

H-2 or H-3-1

We are hearing from some of you in concern over the recent rule change - Now requiring that a job over 15 Tons cannot be cut up into increments to avoid the 15 Ton rule requiring an H-2 license.

The Board regards this change as necessary to protect the public. Although the process was started over a year ago the Board didn't know whether it would make it through the rulemaking process until it had passed through the Rules Commission and the required 30 days at the legislature. It would have been premature for us to start procedures to enforce it until after that had happened.

All H-3-1 licensees have received letters informing them that if they can prove the required amount of work over 15 Tons (even though cut up) we would qualify them to sit for the September 5th exam. In addition another exam/re-examination will be given October 11, 2000. We qualified 325 H-3-1 licensees to sit for the exam. Twenty-five did not show up even though we had ordered the exams for them.

If you haven't been doing the work it won't impact you. The next newsletter will contain further information on this issue such enforcement and specifics on possible situations.

Many H-3 licensees are now moving forward to take the H-2 examination being offered by the Board in September and October of this year. The Board is well aware of concerns being voiced by many H-3 contractors and feels that if you as a licensee will step forward on your own to get the facts surrounding this rule change, not listen to supply house gossip, or some local government agency, who does agree with the Boards position, but call this office, we will be glad to talk with you or meet with any group. I feel certain that any of you who hold an H-3 license from this Board will agree that bar of competency has to be raised to protect the public.

At the present time, the Board is moving forward with computer testing, I must say that we are navigating through some temporary problems with the program, but feel confident that very soon we will be handling test applications and testing in a period of time unheard of in the past. Again, remember to attend the public forums and hearing to be held this month and the first week in October for discussion on Continuing Education and other topics.
