## Message from Sandra O'Brien, Executive Director

#### **Resolution Conferences**

Resolution Conferences have been held for several months now and I am happy to report that we are succeeding in accomplishing our goals.

At first we were apprehensive that licensees would fail to realize the seriousness of the problems and fail to attend. While we have had several contractors that have called and tried to cancel the most of them have ultimately shown up.

The several licensees that ignored the invitation letter and did not attend the conference suddenly called and wanted to meet when they received the paperwork notifying them that the Resolution Committee held the conference without them.

These conferences are a rare opportunity for the licensees to have input by discussing the complaint and having the time to explain their side of what happened. The licensee is also given input into what the result of the conference will be. When it is apparent that the licensee is lacking in knowledge in a specific area they may be given the opportunity to obtain education in that area. This type of agreement may actually keep a contractor's license from being suspended. When some of the complaints were headed towards an obvious suspension we were able to hold that in abeyance allowing the licensee to perform in other ways in order to prove that they were capable of change.

We have held a total of 66 Resolution Conferences with an agreement being reached between to licensee and the committee the majority of the time. The committee has withdrawn two agreements and forwarded several to a Formal Hearing when an agreement could not be reached.

A licensee has 30 days after receiving written verification of the agreement to reject their signed agreement and move forward to a Formal Hearing. Two have chosen to rescind their agreement.

## More on Mismatched Systems

Our Spring 2002 newsletter carried an article regarding mismatched equipment, written to make sure that HVAC contractors remember the concerns about mixing incompatible equipment which may arise during an investigation following complaints to the Board.

The article generated a number of calls to the Board and to the Building Codes section of the North Carolina Department of Insurance. A variety of interpretations and reactions from various inspection departments were noted. In particular, distinctions between new installations and replacements, and between major and minor components were noted.

General Statutes 153A-357 and 160A-417 require a permit for the general repair or

replacement of any heating or cooling equipment. The Board understands "general repair" to refer to major repair, which ordinarily involves major components. Licensees of the Board are aware that minor repairs do not require a license from this Board, and may not require a permit from the local inspector.

Many repairs involve only the replacement of defective parts. While replacement parts should work with the equipment being repaired and be installed in accordance with the manufacturers installation instructions, the Board recognizes that this may not always be possible. Older HVAC equipment may not have matching replacement parts nor manufacturers

installation instructions available; however, the systems should function properly with the replacement parts.

When a heating contractor replaces HVAC equipment with replacement parts not matched to the HVAC equipment, the Board holds the licensee responsible to assure that the replacement parts work as intended in the HVAC equipment being repaired or replaced. The heating contractor will be held accountable for any failure of the HVAC equipment or deficient operation resulting from replacement equipment incompatible with pre-existing or replaced components. The Board encourages all heating contractors to verify that replacement components used in existing HVAC equipment will work in that existing equipment, and wish to emphasize that the Board must hold the heating contractor responsible for any repair or replacement.

Local inspection departments can issue permits for the repair or replacement of existing HVAC equipment but, according to the NCDOI, have no authority to require letters from equipment manufacturers approving replacement parts or equipment. The advice from the Board to obtain a letter from the manufacturer of the equipment to be mismatched is intended to protect the heating contractor in any situation where compatibility, whether in size, rating or listing, may be an issue. It is not intended, let alone mandated, that inspections departments should withhold permits or require total replacement of HVAC equipment in lieu of the more economical replacement of defective parts or equipment. The local inspector has discretion which should be and usually is exercised wisely.

When making field investigations our staff has concluded that many other factors may cause a system to operate below peak performance. Some of these factors are as follows:

- Restricted or kinked refrigerant lines
- Improper refrigerant charge
- Inadequate or improper wiring
- Restricted condenser airflow
- Restricted evaporator airflow
- Leaky ductwork
- Improperly hung ductwork
- Improper duct distribution
- Inadequate existing supply or return
- · Clogged filters
- Mismatched or inappropriate equipment for the application.

To design an optimal system, the contractor must start with proper heating and cooling load calculations. A properly sized coil or blower/coil unit and condensing unit can then be selected based on the certified performance data of the equipment selected. The selection may or may not be components of the same brand. Performance data of all condensing unit manufacturers as well as major coil and blower/coil units are spelled out in their respective specification sheets. However, experience shows that consumers, competitors and inspectors are more likely to question the licensee who mixes and matches.

## Helpful Tips To Tell Clients During Extreme Hot Spells

- Keep grass clippings and leaves away from your outdoor unit. This keeps dirt and debris from getting into your system. It also keeps the airflow path clear;
- Keep furniture and carpeting away from grills and ductwork. If you block your air conditioning system's ability to deliver air, you rob yourself of the cooling necessary to keep your home comfortable;
- Change or clean your filter once per month. Dirty filters cause your system to work harder, which means more energy use and higher utility bills;
- Keep your west-facing drapes, shade or blinds drawn in the afternoon. Keeping the sun out will keep your home cooler.
- Run your dishwasher, washing machine and dryer in the evening hours;
- Don't use your oven;
- Keep your fan running. It helps to keep the air moving;
- Don't let your system go into setback. During high temperatures, the recovery time from a setback function does not help with your comfort;
- Don't overrun an exhaust fan. It pulls the air conditioning out of the house;
- Use a programmable thermostat. This allows you to cool your home only when you need it;
- Zone your heating and cooling system. If you spend most
  of your time in one part of the home or if different people
  in your home want the temperature at different settings,
  then zoning can help you be more comfortable and save
  money on your utility bills;
- Use an attic ventilator. By pulling hot air out of your home, you can keep your home cooler in the summer;
- Have your cooling system checked once per year by an ACCA member contractor. Your equipment works more efficiently when it is clean and running properly;
- Before you call for service: Check the batteries in your programmable thermostat ( if it has them ), check that your breakers are on, and check that your thermostat is set to "cool." If your system seems to be running all the time, check to see if the thermostat's fan position is set in the "on" position;
- Be patient. Remember that contractors are working as fast as they can;
- Be kind to the serviceperson when he or she arrives at your house. Remember that he or she is working in the heat and are doing the best they can.

## Dealing With Summer Heat

#### **Heat Exhaustion**

#### What Happens to the Body:

Headaches, dizziness/Light Headedness, Weakness, Mood Changes (irritable, or confused/can't think straight). Feeling Sick To Your Stomach, Vomiting,/Throwing Up, Decreased and Dark Colored Urine, Fainting/Passing Out, and Pale Clammy Skin.

#### What Should Be Done:

- Move the person to a cool shaded area to rest. Don't leave the person alone. If the person is dizzy or light headed, lay them on their back and raise their legs 6-8 inches. If the person is sick to their stomach lay them on their side.
- Loosen and remove any heavy clothing.
- Have the person drink some cool water (a cup every 15 minutes) if they are not feeling sick to their stomach.
- Try to cool the person by fanning them. Cool the skin with a cool spray mist of water or wet cloth.
- If the person does not feel better in a few minutes call for emergency help (Ambulance or Call 911).

(If heat exhaustion is not treated, the illness may advance to heat stroke.)

#### **How to Protect Workers**

- Learn the signs and symptoms of heat induced illness and what to do to help the worker;
- Train the work-force about heat-induced illnesses.
- Perform the heaviest work in the coolest part of the day.
- Slowly build up tolerance to the heat and the work activity (usually takes up to 2 weeks).
- Drink plenty of cool water (one small cup every 15-20 minutes)
- Wear light, loose-fitting, breathable (like cotton) clothing.
- Take frequent short breaks in cool shaded areas (allow your body to cool down).
- Avoid eating large meals before working in hot environments.
- Avoid caffeine and alcoholic beverages (these beverages make the body lose water and increase the risk for heat illnesses).



## **Code Interpretations**

#### **PLUMBING CODE**

Add to Table 702.4 as follows: Polyvinylchloride (PVC) Plastic ATSM F 1866 (10" Diameter and Larger)

#### DOI INTERPRETATION:

The PVC pre-fabricated fitting (ASTM F1866) may be used for drainage piping 10" diameter and larger. The PVC pre-fabricated fitting (ASTM F1866 may be used for storm drainage piping (Tables 1102.4 & 1102.5).

Section 706.3—Installation of Fittings—sanitary tee patterns shall not receive the discharge of back-to-back fixtures or appliances with pumping action discharge.

#### DOI INTERPRETATION

The above would not apply to back-to-back water closets but would apply to fixtures or appliances with pumping action discharge (clothes washers, etc.).

Section 708.7—Minimum Size—Cleanouts shall be the same nominal size as the pipe they serve up to 4 inches (102mm). For pipes larger than 4 inches (102mm) nominal size, the minimum size of the cleanout shall be 4 inches (102mm).

#### DOI INTERPRETATION

The same nominal size as the pipe they serve up to 4 inches will include the 4" pipe size.

Section 705. 14.2—Solvent Cementing—Joint surfaces shall be clean and free of moisture. A purple primer that conforms to ASTM F656 shall be applied and cement not purple in color shall be applied to all joint surfaces.

#### DOI INTERPRETATION

Purple primer shall be used on all PVC pipes.

**DURHAM, ALONZO TRENT 12/6/99** 

Owner, TRIPLE D'S SERVICE License #19164 H-3-I Raleigh, NC Allegations of incompetence in the business of heating contracting in that installations by respondent failed city inspections repeatedly, demonstrated lack of knowledge and understanding of the building code, installed ductwork which was severely restricted, utilized panned joints in ductwork system but failed to insulate panning material; failed to install exhaust vent 4' from window as required; installed trunk line going downhill, failed to obtain permit, failed to place unit on concrete pad, installed return air plenum sitting in direct contact with ground with improperly made joints and piled dirt against equipment to conceal deficiencies; taped doors on the furnace because frame was bent, failed to properly fit supply plenum to furnace and failed to properly seal plenum; slid air conditioner coil into opening of supply plenum, failed to properly seal or slope the air conditioner coil, improperly cut a hole in heat exchanger end of furnace cutting a structural member of furnace in recess; failed to install filter racks allowing filter to fall down inside return box and wrapped furnace casing with duct insulation to conceal work. Order issued by the Board 1/25/02 revoking license of respondent.

HYDE, CHARLES MARTIN 9/10/01 License #19333 H-3- Clyde, NC Allegations of incompetence in the business of heating contracting in that respondent failed to provide adequate supervision, engaged in threatening and abusive behavior toward customer.

Summary Procedure held 12/12/01.

Final order issued by the Board on 2/13/02 entering a Letter of Warning on the license record of respondent.

JOHNSON, LARRY KEITH9/18/01 License #23246 P-I Charlotte, NC

Allegations of misconduct in the business of plumbing contracting.

Respondent failed to complete installation, failed to renew license after promising to do so, promised Board staff he would obtain the Certificate of Occupancy by 7/13/01 but failed to do so, failed to adequately support PVC building drain piping every four feet, used a brick to support a piece of the PVC building drain piping, failed to connect the CPVC piping for the Second floor to the hot and cold water mains, failed to use PVC primer/cleaner prior to gluing joints under the kitchen sink; and installed the stack within 5/8" of a structural member.

Final Order issued by the Board 1/2/02 ordering the respondent to present evidence from the homeowner within 30 days of the date of the Recommended Order that the installation has been completed to the homeowner's satisfaction and has passed final inspection; upon presentation to the Board of satisfactory completion of the installation, a Letter of Warning shall be entered on the license record of respondent admonishing him to obtain written contracts signed by both the respondent and the homeowner and improve communications with homeowners in the future. Then in the event respondent fails to provide proof of satisfactory completion of the installation, Respondent's license to engage in business as a plumbing contractor be revoked.

JOHNSON, PAUL DAVID 8/17/01 License #18111 H-3-II Matthews, NC Allegations of incompetence in the business of heating contracting in that respondent failed to provide adequate supervision resulting in 3 failed inspections, failed to properly install flexible ductwork joint, installed copper gas piping in contact with black iron and with cement block pier, failed to seal floor register boot, failed to insulate floor register boot, installed PVC flue piping with less than 1/4" per foot rise, failed to properly support PVC flue piping, installed PVC flue piping and PVC condensate piping using a one-step cleaner/glue, failed to clean/prime PVC flue piping and condensate piping prior to gluing fittings, installed PVC flue termination within 12" of adjacent wall, failed to properly support PVC condensate piping, installed a 14" diameter return air flexible duct for a 2.5 ton unit located in the crawl space, failed to seal secondary drain line at drain pan, failed to seal takeoff collars at the ductwork, failed to entirely seal ductwork, failed to seal cabinet openings at evaporator coils where refrigerant piping and condensate piping enter, failed to seal dryer exhaust piping along longitudinal joints, failed to properly fasten one floor register boot on first floor to the structure, installed flexible ductwork so that it has more than 1/2" per foot fall and is restricted by hanger straps and failed to properly support gas piping and condensate piping in the attic.

Final Order issued by the Board on 2/13/02 placing the license of respondent on probation for 1 year with provisions that respondent have written contracts, obtain permits as required, maintain job files and service logs and records detailing his compliance with the provisions of this order, enroll in and pass a course in AHR Comfort Cooling or equivalent court at Piedmont Community College approved by staff of the Board and commit no violation of Article 2, Chapter 87 or the Rules of the Board.

JONES, LEE ROY 10/01/01 Huntersville, NC License # 19655 H-3-II Allegations of incompetence in the business of heating contracting in that Respondent failed to seal the return air patch on the bottom of the unit; failed to cover the return air filter which is allowing unfiltered/ unconditioned air to enter the system; improperly made the return transition so as to allow only partial use of the return air filter; failed to install a drip leg on gas piping; installed the flexible gas connector entering into the cabinet of the furnace; improperly supported both the furnace and coil; installed the supply transition larger than the unit opening; failed to install the b-vent flue piping with a quarter-inch per foot rise; failed to complete refrigerant piping insulation; failed to install condensate piping; allowed his license to be used to obtain the permit and provided no supervision; installed the collar into the duct opening with screws instead of using an approved method; failed to properly protect the copper gas piping within three feet to grade; failed to properly install the gas piping sleeve into the wall; failed to properly support flexible ductwork every five feet; failed to replace vapor barrier that had been torn; provided such inadequate supervision with the result the installation failed rough-in inspection twice and failed final inspection three times; failed to obtain final inspection on either of two permits; installed the flexible gas connector so as to enter through the cabinet of the gas pack; failed to protect the control wiring: failed to protect the copper gas piping within three feet of grade; failed to properly support the copper gas piping; used an electrical tie to serve the gas piping; failed to properly sleeve the gas piping at the masonry wall; failed to fasten the supply duct on all sides to the unit; used improper starting collars; failed to remove debris from the installation of duct board; used regular sheet metal collars instead of ductboard starting collars; the installation of duct board; used regular sheet metal collars instead of ductboard starting collars; failed to bend all tabs on the collars; failed to install balancing dampers; installed the return air opening flange with an undersized collar; in a three-ton system; utilized improper flexible duct connections;

#### CHANGE OF ADDRESS

The Board's rule, 21 NCAC 50.0408 (c) reads as follows:

(C) The licensee shall notify the Board of any change in location or mailing address from that shown on the last license renewal invoice within 30 days after the change takes place.

The above rule requires you to notify the Board of a change of address within 30 days after the change takes place. Compliance with this rule benefits you and the Board. The Board is able to keep its records up to date if you notify the office of an address change. The Board is also able to keep you up to date if it has your correct address. Through the newsletter, the Board notifies you of new requirements for licensed contractors, code amendments, educational opportunities, public rule hearings that may affect you, and much more. The newsletter will not get to you if the Board does not have your correct address. The Board notifies you when your license is going to expire and sends you an invoice. This invoice will not get to you if the Board does not have your correct address.
