A Time To Reflect

Twenty-eight years ago the Board hired a young fiery red head to be a field investigator. This person took great pride in his work and was determined to be the best at his job. Today the hair is white but the determination and drive are still a vital part of his character. Many of you know by now that I am speaking of Bill Tomlinson.

As I have had the privilege to get to know Bill it became quite apparent he was extraordinary in his dedication and loyalty to the Board. I am grateful that he transferred some of that loyalty to me as Executive Director. His vast knowledge and love of the industry has had me in awe on many occasions. To put it simply he has enabled me to do a far superior job as Executive Director than would have been possible without him. I will always be grateful for having known and worked with Bill.

In August, Bill informed the Board that he plans to retire April 1, 2003. The Board expressed appreciation for the many years of work and let him know that he will certainly be missed. Below is Bill's letter to the Board that I wish to share with you.

To the Board of Directors: Bill Tomlinson

I would like to take this opportunity to inform the Board that I will be retiring effective April 1, 2003.

It has been my pleasure to serve under eight different chairmen, three executive secretaries, eight different field staff personnel, thirty some different Board members, and office support staff, too many to name, including our present group of Doris Conklin, Dolores Carmona, Judy Stewart, Karen Cowan, Michele Faison, Scott Waterhouse, Sharon

Pittman, Elizabeth Rose and Vanessa Brown. I have worked one hundred counties by myself, half the state with two field staffers, one third with three and finally I see four field staffers who I think rank above any other construction Board staff working in our state.

I can remember when our office was full of file cabinets and the Board members barely had room to move around. There was no room for witnesses and the Board's initial table was 4x6 and made out of metal and was shared by the Executive Secretary. We moved down to more spacious offices at the State Employee's Credit Union on Hillsborough Street, then on to our past location on Wake Forest Road and now our own building that we can all be proud of for years to come.

I can remember when Nick Fountain and Ruffin Bailey were counseling the Board and Nick had sandy blond hair. When the grandfather clause of 1971 was being played out, the citizens of our state complained to the Attorney General's office about any and all problems and the consumer division was born.

I have vivid memories of working all over the state with Nick Fountain, interviewing witnesses in their homes in preparation for the first case I ever investigated that ended in a license revocation.

My memories take me back to running an old mimeograph machine spitting out exam sheets with ink all over everything and walking down to Case Blue Printing Company and returning with a huge roll of drawings or prints to be used on exams, and sitting

around the Board table with all staff members assembling the tests and boxing everything in preparation for an exam. Then walking down Fayetteville Street pushing a hand truck with reference materials and tests to the Sir Walter Hotel where we gave the test. My first test period covered not quite three hundred people over four days and an eight hour test was eight hours.

I remember when we moved our test site to the Holiday Inn high rise on Hillsborough Street and then on to the McKimmon Center where our applicant numbers got so large that we had to move the plumbing exam to the State Fairgrounds for several periods because it was a larger facility and how every room in the McKimmon Center was filled by applicants from this Board when our number exceeded two thousand per exam cycle.

I can remember when it took me over five hours to drive to Asheville, four to Manteo, three to Wilmington and now we all know how quick we can move about our state.

I can remember when Lee Hauser was appointed Deputy Commissioner of Insurance and how he led the Department of Insurance for years before retirement and when it dawned on me that someone could write a letter full of words and say nothing, along the way I saw a few masters of the art, Fred Bates, Joe Lee, Lee Hauser and Tom Phillips just to name a few.

I can remember when the Board asked for a new interpretation of our H-2 requirements and all the follow-up work that was required to make our H-2 what it is today and all the licensees who supported the Board during that period of time.

Who can forget all the work and cost involved in the new computer programs being used at this time coupled with the scanning of hundreds of thousands of documents; which helped to eliminate countless filing cabinets and speeded up our response time for requested information.

I have been asked many times who my favorite among all Board members would be – when you look back nearly thirty years everything tends to run together, but I do remember a few because of the unusual flavor they brought to the Board. Mr. J.M. Jarrett who smoked big cigars and always made the motion to close all meetings, Wade Pyatt, a tobacco chewing H-3 member who lunched often at the Governor's Mansion; Dr. E. T. Chanlett, the greatest writer of the English language I ever saw; Mr. Malachi Goforth and his handle bar mustache, who had an untimely death in 1999 and John Ward. What can one say about Mr. Ward other than his all around loyalty to this Board and the effort put forth for our industry.

I think the hardest part about retiring is how am I going to cope with missing the many friends that I have accumulated in places like; Kernersville, Asheville, Shelby, Fayetteville

and the numerous communities across our state in my twenty-eight plus years with the Board.

Countless inspectors, contractors, consumers and most of all our current office staff who have always shown me the highest courtesy and regard.

I would hope as I plan my retirement that after I am gone everyone will remember me as understanding of staff and above all loyal to their Board. One does not serve in a job such as mine without having a mate who understands and supports you in your effort. This I have, Jean, my wife of forty-five years, who has been my greatest supporter and encourager over the years.

How does one thank our Chairman, Norman Whitaker, for his many years of friendship and our Executive Director and Board members for the support each has given and the close working relationship with Ms. O'Brien, our Executive Director, for her trust. I could go on and on with praises and thanks to each person for making my life just a little richer and better for allowing me to have your friendship and for that I say thank you.

Below is a copy of Senate Bill 1217 that passed during the last week of the 2002 General Assembly

SECTION 36. (a) G.S. 87-21 is amended by adding a subsection to read:

"(i) The provisions of this Article shall not apply to a retailer, as defined in G.S. 105-164.3 (35), who, in the ordinary course of business, enters into a transaction with a buyer in which the retailer of a good and the services necessary for the installation of the good, contracts with a licensee under this Article to provide the installation services if the contract, containing the licensee's license number, is signed by the buyer, the retailer, and the licensee. All services rendered pursuant to this section by the licensee must be performed in compliance with all local permit and inspection requirements."

SECTION 36. (b) This section becomes effective March 1, 2003



The Inactive List

Many of our licensees for one reason or another desire to have their license put on what they call the "Inactive List". Apparently this is a carry over from many years ago when one could put his/her license on "hold" with no fee charges.

The ability to let your license go "inactive" with no charges has been out of the general statutes for several years now and regardless of whether you fail to renew or keep the license active, you must pay for every year you have a license. It does not matter if you use it or not.

If you fail to renew your license for a period of up to three years you will be responsible for all licensing fees during that period of time as well as meeting the continuing education requirements.

NEWS FLASH Renewal Time Is Here

- DO NOT SEND payment without the renewal form.
- Renewals <u>must</u> be returned to Board office by Dec. 31, 2002.
- © Continuing Education (CE) hours <u>must</u> be completed to renew license for 2003.
- Master license holders need to verify that their sub-licensees have completed CE requirements in order to renew license.
- Fire Sprinkler Contractors are to send a copy of NICET certificate with renewal form.
- Inspectors are to send a copy of their current inspector card(s) with renewal form.
- Incomplete renewal will be returned.
- If you have not completed your continuing education hours DO NOT send in renewal form until CE hours are completed.
- Fig. If continuing education hours have not been completed renewal form and payment will be returned.



CHANGE OF ADDRESS

The Board's rule, 21 NCAC 50.0408 (c) reads as follows:

(C) The licensee shall notify the Board of any change in location or mailing address from that shown on the last license renewal invoice within 30 days after the change takes place. The above rule requires you to notify the Board of a change of address within 30 days after the change takes place. Compliance with this rule benefits you and the Board. The Board is able to keep its records up to date if you notify the office of an address change. The Board is also able to keep you up to date if it has your correct address. Through the newsletter, the Board notifies you of new requirements for licensed contractors, code amendments, educational opportunities, public rule hearings that may affect you, and much more. The newsletter will not get to you if the Board does not have your correct address. The Board notifies you when your license is going to expire and sends you an invoice. This invoice will not get to you if the Board does not have your correct address.
