Debunking Board Myths

Myth #1: *But I thought there was a GRACE period.*

Answer: Year after year Board staff receive phone calls and letters from licensees who thought there was a Board Rule stating licensees had a grace period for renewing their license. So, let's set the record straight. There is **NO** grace period for license renewal. ALL licenses expire on the last day of December in each year following their issuance or renewal, according to G.S. 87.22. Basically, if you do not renew your license by the last day of December your license will be expired and you will not have a valid license to do work. So, as soon as when you receive your license renewal notice from the Board, fill it out, include license fee, and mail it back to the Board to keep your license from expiring.

Myth #2: *I'd like to place my license on hold or shelf it.*

Answer: The Board does not have the ability by Law or otherwise to place a license on the shelf or hold till a licensee decides to use it. According to Board Rule 21NCAC.50.0409, An expired license may be reinstated within three years of the date of expiration upon written request and upon payment of the current license fee, the license fee for the unpaid prior years, the processing fee imposed by G.S. 87.22 and evidence of continuing education for each prior year as required by Rule .1401 herein. After a license has been expired 3 years it will be retired and the only way to reinstate the license is to take and pass the Board's exam for the license type being sought.

Limited Fire Sprinkler Inspection Technicians Deadline Approaching

NCAC 21.50.0306 (d): After July 1, 2004, applicants for initial licensure in the Limited Fire Sprinkler Inspection Technician classification must submit evidence of Level II certification in "Inspection and Testing of Water-based Protection Systems" by NICET in lieu of examination. License without examination shall be issued beginning July 1, 2003, and ending July 1, 2004, to applicants who meet the experience requirement in Rule .0306. **Where certification based on NICET Level II certification was not required at the time of initial licensure, such certification must be obtained by December 31, 2005. After December 31, 2005, current NICET Level II certification is required as a condition of license renewal.**

What Does An Age “Exemption” Mean?

Over the past couple of years many licensees have requested and were granted exemptions, from the Board, because of their age. Since that time some believe that an exempt only means they don't have to have continuing education and that they can continue to contract work and pull permits. However, this is not true, once a licensee has been granted an exemption and opts not to take continuing education hours he/she cannot continue to contract work or pull permits. To engage in bidding, supervising or other activities requiring license a licensee must meet the continuing education requirements as set forth in the Boards Laws and Rules section 1400.

Please review the Rules below for the definition of exemptions and credits.

.1402 EXEMPTIONS AND CREDITS

- (d) Licensees who are over the age of 65, and who will not be engaged in bidding supervising or other activities for which license is required during the coming year, except as an employee of another licensee, may apply to the Board and obtain an exemption. If exemption is granted and the licensee thereafter wishes to engage in activity requiring license, the continuing education must be completed and satisfactory proof provided to the Board before any activity requiring license is undertaken.

Handling and Disposal of Old Thermostats

One old mercury-switch thermostat contains enough mercury to pollute the typical 60-acre lake. Thermostats should be recycled by licensees through the manufacturers' Thermostat Recycling Corporation (TRC). Under this program, participating supply houses accept old thermostats from contractors for recycling. In North Carolina, these supply houses are R.E. Michel (all), Johnstone Supply (Fayetteville and Jacksonville), C.C. Dickson (New Bern and Hickory), and Lennox Industries (Charlotte). If there is no participating supply house nearby, licensees should contact the local hazardous materials agency for disposal information...do not send mercury-constraining thermostats to the landfill!

ATTENTION PLUMBERS AND PUMP INSTALLERS

In North Carolina, a Certified well contractor must be present at all times when well contractor activities are being conducted. A well contractor activity is defined as the construction, installation, repair, alteration, or abandonment of any well. Activities such as extending a well casing or grouting a well are considered well contractor activities.

A \$1000 civil penalty may be assessed for conducting well contractor activities without a certified well contractor present. This fine may also be assessed for Offering to Perform well contractor activities without being certified.

If you only perform pump work and are not registered with the State, you need to *register* with the State as a *pump installer*. If you currently extend well casings, perform well repairs, “wash in” wells, abandon wells, or engage in any other well contractor activity, you must be *certified* as a well contractor.

CE UPDATE

NC Code Books Now Required At All CE Code Courses

The year 2006 will be a mandatory code year for all plumbing, heating, fuel piping and grandfathered fire sprinkler contractors. Meaning, each licensee will be required to take a minimum of 4 of the 6 continuing education hours in North Carolina code changes and amendments.

Since codes are such a vital part of a contractors business each licensee attending code related courses are now required to have code books at all code courses being taught by approved course providers. Course Providers offering code courses will list in their course advertisements and other promotional material the specific code volumes required for each code course and admonish attendees to bring their copies of the appropriate code books to the class. Do not rely on Course Providers to have books available without first checking with them.

Beginning January 1, 2006 it will no longer be acceptable to attend a code course without the required code books; attendees will have to buy them there (if available) or go home.

Allegations of misconduct in the business of fire sprinkler contracting in that respondent contracted to install and installed a fire sprinkler system for apartment buildings consisting of installation of fire sprinkler systems in 252 apartment units, 13 buildings and approximately 2,500 heads. In close proximity to the completion of the installation leaks began to develop around sprinkler heads, eventually requiring replacement of approximately 100 heads. There was substantial evidence the use of pipe dope rather than Teflon tape caused the leaking. The evidence did not eliminate other possible causes. The problem did not occur on any other installation during this period and the evidence indicated that industry awareness of the product problems was not significant or widespread until well after this installation. The failure of the Respondent to provide ongoing replacement of the defective heads was partly the result of the decision of the general contractor to bring in another firm and partly the result of the bankruptcy of Miller Building Corporation, which occasioned the collapse of Respondents' business..

Order issued by the Board on 2/1/05 terminating the proceeding without further action by the Board.

CHANGE OF ADDRESS

The Board's rule, 21 NCAC 50.0408 (c) reads as follows:

(C) The licensee shall notify the Board of any change in location or mailing address from that shown on the last license renewal invoice within 30 days after the change takes place.

The above rule requires you to notify the Board of a change of address within 30 days after the change takes place. Compliance with this rule benefits you and the Board. The Board is able to keep its records up to date if you notify the office of an address change. The Board is also able to keep you up to date if it has your correct address. Through the newsletter, the Board notifies you of new requirements for licensed contractors, code amendments, educational opportunities, public rule hearings that may affect you, and much more. The newsletter will not get to you if the Board does not have your correct address. The Board notifies you when your license is going to expire and sends you an invoice. This invoice will not get to you if the Board does not have your correct address.

Changes must be in writing with your signature.
